TRWD on behalf of the TRVA is requesting proposals from a nationally recognized consulting firm to provide an independent comprehensive programmatic review of the Trinity River Vision Flood Control Project. The consultant will propose alternative solutions to optimize performance, improve transparency and accountability, promote the effective and efficient use of resources and assist in the identification of future resources needed to meet the intended goals and bring this project to a successful completion.

Given the specificity of the services requested as stated in the official RFP documents, clear and demonstrated expertise must be submitted for consideration. The respondent should be able to include and specify a detailed plan on how each of the review areas stated in the official RFP documents will be assessed and/or evaluated.
