Director Hogsett acted in his capacity as President, and Director Priest acted in his capacity as Secretary, whereupon proceedings were had and done, as follows:

The Directors had previously received copies of the Minutes of a Regular Meeting held on June 15, 1949, at 1:30 P.M. Having found no objections thereto, it was ordered that they be approved, signed and placed on record.

2.

Pursuant to request heretofore made by the Board to Honorable W. O. Jones, City Manager of the City of Fort Worth, for corporate boundaries of such city, as such boundaries existed in April, 1929, and for boundaries of additional areas annexed to the corporate limits to the said City of Fort Worth thereafter from time to time, to enable this District to expand its territorial

boundaries accordingly, there were received from the City of Fort Worth, acting through the City Manager, a written communication dated June 17, 1949, addressed to Mr. Joe B. Hogsett, President of this Board, signed by Mr. Jones, the City Manager of Fort Worth, in which, in substance, he stated that he was submitting a printed copy of the City Charter of the City of Fort Worth, containing description of the city limits of the city as of April 5, 1929, and that such limits were set forth in Chapter XXIX, pages 53, 54, 55, 56, 57, 58 and 59 of the Charter; a city map showing in color the city limit lines of 1928, and the city limit lines of May, 1949, which map discloses ordinance numbers of the proceedings of the city counsel in respect to boundaries of annexed areas and also boundaries that had been deleted from the City of Fort Worth between January 10, 1928 and June 16, 1949. Also two typewritten copies of the boundary description of the corporate limits of the City of Fort Worth as of the date of said letter.

On motion of Director Pier, seconded by Director Hill, it was ordered that said documents and maps be received and filed, and the documents placed among the archives of the District, and the map to be reproduced on linen with multiple copies to insure preservation of such map, and to aid the engineers of the district in tracing such boundaries and in comparing them with the boundaries of the District as those boundaries had existed since the time the District had become a municipal District under the provisions of the Statute.

The motion having been put to the Board, same was unanimously carried, all the members voting "aye" thereon.

There was exhibited and read to the Board a communication in writing, dated June 17, 1949, from Cities Service Oil Company, by Wiley C. above mentioned and that it should be duly deposited to the credit of the Maintenance Fund of the District, in the District's depositary, the Continental National Bank of Fort Worth, Texas.

It having been brought to the attention of the Board that the Government of the United States had announced its willingness to exchange par for par, with the holders of United States Treasury Certificates of Indebtedness, Series F-1949, dated July 1, 1948, maturing July 1, 1949, bearing interest at the rate of 1-1/8%, for United States Treasury Certificates of Indebtedness, Series F-1950, dated July 1, 1949, bearing interest from date at the rate of $1\frac{1}{4}$ % per annum, payable with the principal at maturity on July 1, 1950, in bearer form; and it appearing to the District that such an exchange was, and is, of pecuniary advantage to the District, and it further appearing that the District, at the present time, is the owner of par value \$150,000.00 of bonds; \$50,000.00 owned by the Interest & Sinking Fund and \$100,000.00 owned by the Maintenance Fund, bearing 1-1/8% interest under the old issue as expressed in Fort Worth National Bank Safe Keeping Department Trust Receipt SK No. B 39406, dated July 28, 1948.

On motion of Director Priest, seconded by Director Stone, it was ordered that such exchange par for par be effected, and when the interest on said matured certificates of indebtedness is received by the District it is to be credited to the Maintenance Fund and the Interest and Sinking Fund, proportionately as their interest may appear. Further, that when such new United States

Treasury Certificates of Indebtedness Series F-1950 are received, they shall be placed in the custody of the Fort Worth National Bank in the Trust Department thereof and that Trust Receipt be issued by such Trust Department showing the ownership thereof by the District at which time the District shall surrender to the Fort Worth National Bank, Trust Receipt SK No. B 39406, dated July 28, 1948, issued to this District by said Bank; further, that the said Fort Worth National Bank is hereby empowered on behalf of the District to make the exchange, par for par.

The motion having been put to the Board, it was unanimously carried.

Mr. McNair made recommendation that the Board authorize the purchase from Manning's War Surplus Store of three pair 7x50 MM Binoculars at the price of \$50.00 per pair. The binoculars are for use in patrol duty at the District's lakes.

It was the sense of the Directors that the purchase of the three pair of binoculars at the price of \$50.00 per pair be authorized. It was so ordered.
