MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD IN THE DISTRICT OFFICE IN FORT WORTH, TEXAS, ON THE 19TH DAY OF MARCH, 1951, AT 1:30 P.M.

The call of the roll disclosed the presence or absence of Directors, as follows:

Also present were Sidney L. Samuels, General Counsel, and C. L. McNair, General Manager.

Mr. Hogsett acted in his capacity as President, and Director Priest acted in his capacity as Secretary, whereupon proceedings were had and done, as follows:

1.

The Directors had previously received copies of meetings held as follows: February 27, 1951, at 1:30 F.M.

February 28, 1951, at 2:30 P.M.

March 8, 1951, at 2:00 P.M.

Having found no objections thereto, it was ordered that they be approved, signed and placed on record.

ο.

Attached to these minutes as Exhibit "A" is a statement of the financial condition of this District to which reference is made. Exhibit "A" shows that interim Voucher-Checks #1852 to #1871, inclusive, for the total sum \$3,103.91 had been issued since the last meeting; also proposed voucher-checks #1872 to #1887, inclusive, for

the total sum \$219,318.92. There was full consideration of the proposed voucher-checks and the data to support same, whereupon Director Priest moved, seconded by Director Pier, that the issued voucher-checks above listed be confirmed and that the accounts payable be approved as covered by the proposed voucher-checks and that such checks be issued and delivered to the respective persons entitled to receive them. It was so ordered, subject to the usual audit.

3 •

The monthly report dated March 19, 1951, of Mr. C. L. McNair, General Manager, for the months of January and February, 1951, was received, presented and ordered filed as Exhibit "B" to these minutes.

4.

Mr. McNair presented certain proposals for lease of District's lands for the year 1951, which he recommended for approval, as follows:

Upon consideration of each of the above lease proposals, Director Priest moved, seconded by Director Stone, that the said proposals be approved and closed in the usual manner, subject to the payment of the agreed rentals and execution of written contracts in the form required by the District. It was so ordered.

5.

Following the above mentioned matters, which were disposed of by the Board, Mr.Ben F. Hickey, land agent of the District, made an oral report concerning progress he had made and the institution

of two certain comdemnation suits, one against Angela Spartos, involving 25 acres of land, and one against F.W. Teichmann, involving 11.52 acres.

6.

There was then read by General Counsel for the District, a written communication from Austin, Texas, dated March 13, 1951, from J. E. Sturrock, General Manager of Texas Water Conservation Association, with respect to House Bill 621, introduced and proposed by Representative Dudley W. Peterson of Galveston, at the present Session of the Legislature, which, in substance, provided that whereever public works are constructed by conservative districts, and state highways are affected injuriously thereby or inundated by waters or become impaired or crippled, growing out of the construction of such public works, that the District so engaged in the performance of such task, and before the commencement of the construction of same, should secure written approval of the plans for such public works by the State Highway Engineer, and to make such provisions as might be acceptable to such engineer to finance the relocation or construction or make such revisions of such highways as would be necessary to preserve the integrity and usefulness of such highways. The Bill having been read to the members of the Board, and due consideration having been given thereto, all members concurred that same should be referred to the General Counsel of the District for such action as he may deem appropriate. It was so ordered.

7.

There was placed before the Board foraction a written communication dated the 14th of March, 1951, from Mr. William P. Jones, Jr., Executive Officer of the Corps of Engineers of the United States

Army, now engaged, under act of Congress, in straightening the channel of the West Fork of the Trinity River, in which such communication it was requested that Tarrant County Water Control and Improvement District Number One approve the contract between the Federal Government and the State of Texas, acting by and through the State Highway Commission of Texas.

This contract related to the Underpinning of East Belknap Street
Bridge, Fort Worth Floodway, U.S. Highway #377. The contract having
been reviewed by the Board, and the General Counsel of the District
having approved of the concurrence therein by the Board, on the part
of the District, it was the consensus of the Board that same should be
executed by Mr. Joe B. Hogsett, as the President of the District.
Accordingly, Mr. Hogsett executed his name thereto on behalf of the
District, and it was so ordered thatthe three contracts, each one of
which was a counterpart of the other, together with the signature of
Mr. Hogsett, be transmitted to the Corps of Engineers of the U.S.
Army, 1127 Texas & Pacific Building, Fort Worth, Texas.

8.

There was submitted through the Texas Legislative Service House Bill 579, referred to the Committee on Conservation and Reclamation, a Bill authorizing cities in Texas to annex territory within water control and improvement districts and to purchase the assets and properties of such district and to assume all the debts, liabilities and obligations of same.

The matter of the Bill and the contents thereof were referred by unanimous vote of the Directors present, to Sidney L. Samuels, Counsel for the District, with authority to take such action thereon, for and on behalf of the Board, as he should deem proper and also to furnish the Board with an interpretation of the provisions of the Bill.

9.

After the foregoing proceedings had been completed, Sidney L. Samuels, Attorney for the District, then presented to the Board matters which had been pending for many months in which the District sought to recover possession from the Federal Government that certain Tract or parcel of land known as Tract No. 16, which had been condemned through proceedings in Eminent domain in the United States District Court for the Northern District at Fort Worth by the Federal Government, for its use during the period of World War Two, and which is designated on the docket of said Court as Suit No.432 Civil, which suit was filed in the year 1943.

The Counsel for the District called to the attention of the members of the Board the minutes of July 15, 1949, explanatory of the matter, and also the proposition under which the Federal Government was to release possession of the Tract No. 16 and reconvey the same to the District; and on the other hand, the matter of exchange of properties between the District and the United States Government in which the District should convey to the Federal Government tracts of land embracing 241.46 acres, and the Federal Government as consideration therefor to convey to the District, in fee simple, tracts of land containing in all 241.46 acres of land contiguous to land now owned by the District. These matters are all set forth in preceding minutes of this Board and this summary was made by Counsel of the District merely for historic purposes.

With this prelude or preface, the General Counsel of the District then exhibited the following instruments, to be executed by the District by and through the Fresident and Secretary, which instruments are hereby enumerated as follows:

- 1. A Quitclaim Deed from the Secretary of the Navy of the United States, under which the Government of the United States is to relinquish, surrender and quitclaim to the District all rights, priviliges and interest, including possession, which the Federal Government acquired under the Eminent Domain Proceeding hereinabove referred to, to Tract No. 16.
- 2. A Deed of conveyance to the United States Government from the District wherein and whereby the District conveys to the United States of America 241.46 acres of land, being a part of the Tract No. 16, involved in the Eminent Domain suit hereinabove pointed out, and a deed of conveyance in exchange for the 241.46 acres last hereinabove mentioned under which the United States of America conveys to the District 241.46 acres of land, adjoining and contiguous to Tract No. 16 above mentioned and within the boundaries of the former Marine Corps Air Station at Eagle Mountain Lake.

Copies of all of the foregoing instruments of conveyance, are made a part hereof and attached in folio to these minutes for fuller knowledge of the contents of same.

All said instruments, and each one of same, were read to the members of the Board and considered by the Board, with all the contents, covenants, terms and easements, (where retained) contained therein.

Counsel for the Board also advised the Directors that before

the exchange of properties between the parties, that is to say, between Tarrant County Water Control and Improvement District Number One and the United States Government, could be legally and effectively concluded, it was essential to the validity of the transaction that consent therefor should be granted by the National Congress by due and proper legislation approved by the President of the United States. However, Counsel further advised the Board that such legislation was not requisite for the retrocession of Tract No. 16 to the District by the Federal Government, since by the terms of the condemnation proceedings in Eminent Domain above mentioned, the decree provided that when the Federal Government had ceased to use the property, the Secretary of the Navy of the United States should be empowered to release the same and reconvey to this District. Counsel further explained that it was essential that these instruments, thus prepared by General Counsel, aided and assisted by Mr. McNair, General Manager of the District, should be sent to New Orleans, Louisana to Commandant Eighth Naval District, Federal Building, who, in turn, would transmit said instruments to proper authorities at Washington, D.C. for proper action thereon. Counsel also informed the Board that the conveyance by the District to the Federal Government should not become effective until, concurrently with the delivery by the District of its instruments of conveyance, the Government of the United States should execute and deliver to the District the instruments, in which the District was and is the Grantee.

These matters having been discussed by the members of the Board, and the contents thereof having been fully considered and canvassed, thereupon Director Pier moved, seconded by Director Stone, the adoption of the following resolution:

BE IT RESOLVED by Tarrant County Water Control and Improvement District Number One, that the President of the District, Mr. Joe. B. Hogsett, and the Secretary of the District, Mr. Dan H. Priest, be and they are hereby authorized, empowered and instructed upon the terms and conditions hereinbefore mentioned, on behalf of the District and in its corporate name, to execute and deliver to the Federal Government the instruments of conveyance in which the Federal Government is therein named Grantee; and that the transaction between the respective Governments (the District and the United States of America) be concurrent in point of time so that the District before parting with its title should receive title to the lands to be conveyed to it by the Federal Government.

The motion to adopt said resolution having been submitted to the Board, each of the Directors voted "aye" thereon and no Director voted in the negative, whereupon the President declared that the resolution had been unanimously adopted.

The President then instructed the General Manager and the General Counsel of the District to forward said instruments in keep-ing with the foregoing proceedings.

There being no further business before the Board, the meeting thereupon adjourned.

in consideration of the conveyance by Tarrant County Water Control and Improvement District Number One, a body politic and a public corporation, created under the Constitution of the State of Texas, and of Statutes pursuant thereto, of certain lands amounting in the aggregate to 241.46 acres, (a part of Tract No. 16, described on the Minutes of the United States District Court for the Northern District of Texas, at Fort Worth, in a condemnation proceeding, known as Case No. 432 Civil) has this day granted, sold and conveyed, and by these presents does grant, sell and convey unto said Tarrant County Water Control and Improvement District Number One, three (3) certain tracts or parcels of land amounting in total to 241.46 acres, as set forth and delineated on the plat hereto attached, marked Exhibit "A", and to be taken as a part hereof, as Area "D", Section 1, 217.9 acres; Area "D", Section Two, 14.51 acres; Area "D", Section Three, 9.05 acres; being situated in Tarrant County, Texas, North 32° west approximately 17 miles from the County Court House in Fort Worth, Texas, and is described by metes and bounds as follows: to-wit:

AREA "D", SECTION ONE, FIELD NOTES of a survey of 217.9 acres of land being AREA "D" SECTION NO.1 in the former U. S. Marine Corps Air Station, Eagle Mountain Lake, Texas, said 217.9 acres of land being being a part of the D. T. Flores survey,

Abstract No. 508, and a part of the W. G. King survey, Abstract No. 900, situated in Tarrant County, Texas, North 32 degrees West 17 miles from the County Court House in Fort Worth, Tarrant County, Texas, and is described by metes and bounds as follows, to-wit:

BEGINNING at a galvanized iron pipe driven in the ground in the east line of a 13.68 acre tract of land conveyed by warranty deed by G.W. Duke, et al, to the Tarrant County Water Control & Improvement District No. 1 and recorded in Tarrant County, Texas, Deed Records Book 1118, page 228, said point of beginning being 913 feet East and 300 feet South of the Southwest corner of the J. G. Helms survey, Abstract No. 807, and in an East line of Tract No. 16;

THENCE East 1020 feet to a galvanized iron pipe driven in the ground for a corner;

THENCE North 305 feet to a 3/4 inch galvanized iron pipe driven in an ancient fence line, the north line of the D.T. Flores survey, Abstract No. 508, and the South line of the J.G. the first five-year period, which communication shall be delivered at the offices of the District in the City of Fort Worth, Texas.

The United States of America, the Grantor herein, does reserve perpetual avigation easements (which shall embrace the standard requirements relating to glide angles and approach zones to runways as prescribed by the Federal Bureau of Aeronautics, Shore Establishments Division, Planning Standards for Air Stations in effect prior to 26 October, 1950) over Area "D" Section 1, and Section 3, being a part of the property conveyed herein by the United States of America, to the Tarrant County Water Control and Improvement District Number One, as set forth and delineated on the plat hereto attached and hereinbefore described in this instrument as Exhibit "A".

It is intended, understood and agreed that the United States of America reserves, and the Tarrant County Water Control and Improvement District Number One grants, perpetual avigation rights over those certain lands consisting of that part of Eagle Mountain Lake lying within the trapezoidal area whose centerlines are direct continuations, for a distance of two miles, of the runway center-lines and whose widths at the ends of the runways are 1000 feet (500 feet each side of the end points of, and measured at right angles to, the runway center-lines) and whose widths at a distance of two miles from the ends of runways are 4000 feet (2000 feet each side of, and at right angles to, the continuations of the runway center-lines). These sidelines diverge at an angle of 8° 5° from the continuations of the runway center-lines. The location of the end point and the relative bearing of the North-South runway, contiguous to Area "D" Section 1, and Section 3, are as follows:

The South end of the North-South runway is located North 80° 20' East 1384.03 feet from the Southwest corner of the J.G. Helms Survey (Baker land) and the centerline of said runway bears North 4° 35' West.

It is further intended, understood and agreed that within the areas for which Avigation Rights have been reserved herein that no obstructions shall remain, or hereafter be erected by the fee owner or owners, nor shall any trees or vegetation be allowed to grow beyond a height of one foot for each forty (40) feet of horizontal distance from the ends of the respective runways. The Government may at any time and it is empowered to enter the areas over which such Avigation Rights have been reserved for the purpose of removing or lowering such obstructions.

It is further stipulated that the Grantor herein, in the exercise of the privileges reserved by the terms of the foregoing easement shall and will hold the said Tarrant County Water Control and Improvement District Number One, and its successors and assigns, free and harmless from all damage or injury to persons and property within said area and the vicinity thereof, and will indemnify said Tarrant County Water Control and Improvement District Number One, and its assigns, from all liability incurred by reason of the exercise of the aforesaid privileges.

To have and to hold the three said parcels of land (Area "D" Section 1; Area "D" Section 2; Area "D" Section 3, as aforesaid) to the said Tarrant County Water Control and Improvement District Number One, and its successors and assigns, forever, subject to the easements reserved herein by Grantor; and the United States of America does hereby declare that it is the fee simple owner of the lands herein conveyed.

QUITCLAIM DEED

CITY OF WASHINGTON, DISTRICT OF COLUMBIA.

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, the Government of the United States of America did institute a proceeding in condemnation in the United States District Court for the Northern District of Texas, at Fort Worth, Texas, to condemn for the use of such Government, for and during the period of World War Number Two, a certain Tract of land lying and being situated in Tarrant County, in the State of Texas, the property of Tarrant County Water Control and Improvement District Number One, a political subdivision of the State of Texas, and a body corporate and politic, which such proceeding is styled on the docket of said Court as "Case No.432 Civil"; and

whereas, pursuant to said proceedings a decree was rendered by said Court, granting to the use of said Federal Government said tract of land, which was therein described as Tract No. 16, which decree was rendered on the 9th day of July, 1943, and is of record in Civil Minutes, Volume 27, page 523, of the Minutes of said Court, to which reference is here expressly made; and

WHEREAS, by the terms of said decree, to which reference is hereby expressly made as if incorporated herein, it was provided that said lands so devoted to the uses of the Federal Government should be restored to said Tarrant County Water Control and Improvement District Number One, the fee simple owner thereof, when the Secretary of the Navy of the United States should proclaim that the use of the Government had ceased;

NOW, THEREFORE, in consideration of the premises, and the United States Government having ceased to use the said premises, and by virtue of the terms of the decree, the Secretary of the Navy

now declares that the use of same has ceased, and that the full possession as well as the full title and ownership of said tract should be restored to the said Tarrant County Water Control and Improvement District Number One, free and acquit of any claim of interest therein or thereto by the United States Government;

NOW, THEREFORE, in consideration of the premises, and of the consideration deemed valuable by the Government of the United States issuing from said Tarrant County Water Control and Improvement District Number One; the said Government of the United States, acting herein by and through its Secretary of the Navy, does hereby release, surrender, quitclaim and reconvey unto the said Tarrant County Water Control and Improvement District Number One, all and singular, said Tract No. 16, embracing two (2) parcels of land as recorded in Tarrant County, Texas, Deed Records, Volume 1548, pages 460 and 461, and hereinafter more fully described by metes and bounds as follows, towit:

Said 20.12 acres of land being a part of the D.T. Flores Survey, Abstract No. 508 and being North 33° 30' West 18 miles from the County Court House in Fort Worth, Tarrant County, Texas, and is described by metes and bounds as follows, to-wit:

BEGINNING at the most northerly northeast corner of the D.T. Flores survey, Abstract No. 508 and the northwest corner of the J. G. Helms Survey, Abstract No. 807, said point of beginning being the northeast corner of a 308.7 acre tract of land conveyed January 8, 1930, by warranty deed by R.W. Jackson, et ux, to the Tarrant County Water Control 'Improvement District No. 1 and recorded in Tarrant County, Texas, Deed Records Book 1071, page 515, and a northeast corner of Tract No. 16;

THENCE South 1517 feet with the east line of said Flores Survey, same being the west line of said Helms Survey, the east line of said Jackson tract and Tract No. 16 to a point for the southeast corner of Area "B";

THENCE South 89° West 250 feet to the southwest corner of Area "B", a 1 inch galvanized iron pipe driven in the ground for the corner:

THENCE North 25° 40' West 1701.95 feet to 24 inch post oak tree used for ancient fence corner, tree has 18" blaze on southwest side about 6 feet above ground and stubs of fence wire in trunk, said tree is the northwest corner of Area "B", the southeast corner of 223.30 acre tract of land conveyed March 6, 1930, by warranty deed by A. Gant and wife to Tarrant County Water Control and Improvement District No. 1 and recorded in Tarrant County, Texas, Deed Records Vol. 1108, page 291, said corner is a corner of Tract No. 16 and in the north line of the D.T.Flores survey, Abstract No. 508 and the south line of the D.T. Flores survey, Abstract No. 505; and in the north line of said Jackson tract;

THENCE South 89°/East 1006 feet to the place of beginning and containing 20.12 acres of land.

As a condition to this conveyance by the said Tarrant County Water Control and Improvement District Number One to the Government of the United States, and as part of the consideration for this conveyance by the Grantor herein, the said Grantor does hereby particularly reserve to itself and its successors and assigns, a perpetual easement in, over and upon the two tracts herein conveyed to Grantee for the impounding and depositing of waters whether ordinary

or in flood, issuing directly or indirectly from Eagle Mountain Lake, which was built and constructed, and is now controlled by said District, and the Grantee herein in accepting the within deed of conveyance, waives and renounces any and all claims for damage or compensation therefor or on account thereof.

And, in return for said easement herein above reserved, the said Tarrant County Water Control and Improvement District Number One, the Grantor herein, does hereby grant to the Government of the United States perpetual avigation easements, (which shall embrace the standard requirements relating to glide angles and approach zones to runways as prescribed by the Federal Bureau of Aeronautics, Shore Establishments, Division Planning Standards, for Air Stations in effect prior to 26 October, 1950,) over lands owned by the Grantor and situated contiguous to the ends and in direct continuations of the runways of the former Marine Corps Air Station, Eagle Mountain Lake, particularly AREA "C". Section 1, and the lake portions beyond Areas "A" and "D", Section 1, and "C" Section 2, as set forth and delineated on the plat hereto attached and hereinbefore described in this instrument as Exhibit "A". It is intended, understood and agreed that the avigation rights herein granted shall include those certain lands owned by Grantor, consisting of that part of Eagle Mountain Lake lying within the trapezoidal areas whose center lines are direct continuations, for a distance of two miles, of the runway center lines and whose widths at the ends of the runways are 1000 feet (500 feet each side of the end points of, and measured at right angles to, the runway centerlines) and whose widths at a distance of two miles from the ends of runways are 4000 feet, (2000 feet each side of, and at right angles to, the continuations of the runway centerlines). These side lines diverge at an angle of 8° 5' from the continuations of the runway centerlines. The location of the end point, and the relative bearing of the southwest-northeast runway (contiguous to Area "C", Section 1) are as follows:

The Southwest end of the Southwest-Northeast runway is located North 26° 43' West 1110.75 feet from the Southwest corner of the J. G. Helms Survey (Baker Land) and the centerline of said runway bears North 68° 55' East.

The end descriptions of the other Runways are:
The N.W. end of the NW-SE Runway is located S. 75°
15' E. 936.27 feet from the SW corner of the Hutcheson
Tract and the center of said Runway bears S. 57° 26'
30" E.

The S. end of the N/S Runway is located N. 80° 20° E. 1384.03° from the SW corner of the J. G. Helms-Survey (Baker Land) and the center line of said Runway bears N. 4° 35° 30° W.

It is further intended, understood and agreed that within the areas for which avigation rights have been herein granted to the United States of America, that no obstructions shall remain, or hereafter be erected by the fee owner or owners, nor shall any trees or vegetation be allowed to grow, beyond a height of one foot for each forty feet of horizontal distance from the ends of the respective runways. The Government may at any time, and it is empowered to enter the areas over which such avigation rights have been herein granted for the purpose of removing or lowering such obstructions in the event they should exist.

It is further stipulated that the Grantee herein in the exercise of the privileges permitted by the foregoing easements shall and will hold the said Tarrant County Water Control and Improvement District Number One, and its successors and assigns, free and harmless of and from all damage or injury to perons and property within said area and in the vicinity thereof, and will indemnify said Tarrant County Water Control and Improvement District Number One, and its assigns, from all liability incurred by reason of the exercise by the Grantee of the aforesaid privileges.

IN WITNESS WHEREOF, the Tarrant County Water Control and Improvement District Number One, in accordance with resolutions of its Board of Directors, has on this the 28th day of April, A.
