MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD IN THE DISTRICT OFFICE IN FORT WORTH, TEXAS, ON THE 12TH DAY OF FEBRUARY, 1954, AT 1:30 P.M.

The call of the roll disclosed the presence or absence of the Directors, as follows:

#### PRESENT

Joe B. Hogsett Houston Hill W. L. Pier

#### ABSENT

Dan H. Priest A. T. Seymour, Jr.

Also present were Messrs. Sidney L. Samuels and John M. Scott of the legal staff of the District, C. L. McNair, General Manager of the District, and Joe B. Mapes of the engineering firm of Freese and Nichols, Consulting Engineers of the District.

Director Hogsett acted in his capacity as President, and in the absence of Director Priest, Director Pier acted as Secretary, whereupon proceedings were had and done as follows:

1.

Attached to these minutes as Exhibit "A" is a statement of the financial condition of this District to which reference is made.

Exhibit "A" shows that proposed voucher-checks #4834 to #4924, inclusive, for the total sum \$119,461.20 had been issued since the last meeting. There was full consideration of the proposed voucher-checks and the data to support same, whereupon it was moved and seconded, that the issued voucher-checks above listed be confirmed and the accounts payable be approved as covered

by the proposed voucher-checks and that such checks be issued and delivered to the respective persons entitled to receive them. It was so ordered, subject to the usual audit.

2.

President Hogsett reported to the Board that the Fort Worth National Bank of Fort Worth had made reinvestments for the District as follows:

- (a) Out of the \$800,000.00 proceeds United States Treasury
  Bills, dated November 5, 1953, maturity February 4,
  1954, owned by the Construction Fund, there was reinvested for the use and benefit of said fund the sum
  \$797,966.25 in United States Treasury Bills, dated
  February 4, 1954, maturity May 6, 1954. The difference
  in the proceeds of the maturing bills and the cost of
  the bills dated February 4, 1954, maturity May 6, 1954,
  amounted to \$2,033.75 for which sum the Fort Worth
  National Bank issued its Cashier's Check No. B 725567
  for \$2,033.75, payable to the order of this Distirct,
  which is to be deposited in the Continental National
  Bank of Fort Worth, the District's depositary, to the
  credit of the Construction Fund.
- (b) Out of the \$175,000.00 proceeds United States Treasury
  Bills, dated November 5, 1953, maturity February 4, 1954,
  owned by the Interest and Sinking Fund, there was reinvested for the use and benefit of said fund the sum
  \$174,543.25 in United States Treasury Bills, dated
  February 4, 1954, maturity May 6, 1954. The difference

in the proceeds of the maturing bills and the cost of the bills, amounted to \$456.75 for which sum the Fort Worth National Bank of Fort Worth issued its Cashier's Check No. B 725565 for \$456.75 payable to the order of this District, which is to be deposited in the Continental National Bank of Fort Worth, the District's depositary, to the credit of the Interest and Sinking Fund.

President Hogsett then reported that the above described securities were in the safekeeping department of the Fort Worth National Bank for which the District holds the Bank's official Trust Receipts, and he presented to the Board three Trust Receipts described as follows:

- (a) SK No. B 52269 for \$800,000.00 par value, United States
  Treasury Bills dated February 4, 1954, maturity May 6,
  1954, owned by the Construction Fund.
- (b) SK No. B 52270 for \$175,000.00 par value, United States Treasury Bills dated February 4, 1954, maturity May 6, 1954, owned by the Interest and Sinking Fund.
- (c) SK No. B 52286 for \$25,000.00 par value, 1-3/4% Tarrant County Water Control and Improvement District Number One Improvement Bonds, Series 1950, dated December 15, 1950, maturity December 15, 1972/70.

All the Directors present voted to receive the said Trust Receipts and ordered that they be deposited for safekeeping in Lock Box 984, at the Continental National Bank of Fort Worth, Texas, the Depositary of the District, and that the action taken in the fore-

going transactions, all and singular, be ratified and approved. It was so ordered.

3.

Through Mr . Mapes, of the Engineering firm of Freese and Nichols, Engineers for the District, there was presented and read to the Board of Directors who were present a communication on the letterhead of Ottinger Construction Company, dated February 9, 1954, addressed to Messrs. Freese and Nichols, concerning the matter of the West Seventh Street Bridge, a carbon copy of said letter having been received by the District is to be attached to these minutes and made a part hereof. In this letter the Ottinger Construction Company, through Mr. E. C. Ottinger, stated that under the terms of the Contract with the District in the matter of the improvement of the West Seventh Street Bridge, the Ottinger Construction Company was to notify the District in writing of the date when such improvement was "substantially complete". The letter continued to say that on February 8, 1954 "we poured our last floor slab, and that this slab was poured with the use of 'quick setting' cement". Mr. Ottinger, in this letter, further stated that the "quick setting" cement was used in the hope of expediting the use of the bridge for traffic, if necessary, and that this bridge could be used the morning of February 9, 1954, and that, therefore, the Ottinger Construction Company respectfully requested that its contract time be stopped as of midnight February 8, 1954. In the conclusion of the reading of this communication the Board of Directors unanimously resolved that the communication should be referred to Mr. Marvin C. Nichols before passing on the letter from the Ottinger Construction

Company. Each and all of the Directors voted aye thereon.

4.

Mr. Ben F. Hickey, Land Agent of the District, presented to the Board the necessity to make purchase on behalf of the District from Western Tractor Company of Fort Worth a Ford Tractor for use in levee maintenance, and that the price of same was \$2,132.50.

Mr. Hickey also stated to the Board the necessity for purchasing another Ford Tractor from the same Company for use in maintenance of Eagle Mountain Lake and Reservoir and that the price for same was \$2,118.50.

Mr. Hickey further stated to the Board that he should also be permitted to purchase for the use of the District and from Highway Machinery Company of Dallas, Texas, one new Austin-Western Model (Super 88) with Buda Diesel, equipped with 1300 x 24 tires and scarifier complete, ready to work and delivered f.o.b. Fort Worth, Texas, and that the price for same was \$14,000.00.

The Board having considered the foregoing needs so presented by Mr. Hickey, were of the opinion that the machinery above mentioned was needed for the use of the District and should be purchased, and that Mr. Hickey be authorized for and on behalf of the District to make such purchases upon the terms hereinabove set out, thereupon Director Hill, seconded by Director Pier, moved that Mr. Hickey be clothed with authority to make such purchases, which motion was unanimously carried. Each and all of the Directors voting aye thereon.

5.

Mr. Hickey then submitted to the Board of Directors cer-

tain land matters in the purchase of properties needful to the District in carrying out Program B. Mr. Hickey then stated to the Board that he had carried on negotiations for the purchase of such land and properties for the District with three (3) persons who reside in Fort Worth, Texas, to-wit:

Socrates Klidas
Penelope Klidas, a widow
Alexander Klidas

and that the purchase price to be paid for the lands included easements and damages to growing crops amounting in the sum total of \$8,105.00, that the lands so purchased for the District are situated in Tarrant County, Texas, propertities of three (3) persons above mentioned, which lands are more particularly described by metes and bounds as follows:

"A portion of block 4 of Bailey Gardens, an addition to the City of Fort Worth in the R. Crowley and J. Baugh surveys in Tarrant County, Texas, as said block appears on the map of record in Vol. 939, page 569 of the deed records of said Tarrant County and embracing a portion of the tract conveyed to Jim Klidas by a deed of record in Vol. 934, page 86 of said Deed Records.

Beginning at the southwest corner of said Block 4 in the middle of the West Fork of the Trinity River.

Thence North 26 degrees 05 minutes East, along the westerly line of said block, 376-9/10 feet to an iron.

Thence North 77 degrees 14 minutes East 404-1/10 feet to a point in the easterly line of said block from which an iron bears north 77 degrees 14 minutes east 180-8/10 feet.

Thence South 18 degrees 49 minutes West, along said easterly line 335-2/10 feet to the southeast corner of said block in the middle of said river.

Thence Southwesterly, up said river with its meanders, along the south line of said block 465 feet to the place of beginning and estimated to contain two and eighty-seven one hundredths (2-87/100) acres."

Mr. Hickey further stated that the purchase of these lands included several elements:

- (a) The tract of land hereinabove particularly described;
- (b) An easement of right-of-way over and across said lands for the construction of a channel or channels, designed for flood control and flood prevention along the Trinity River in Tarrant County, Texas.

Further in stating the calculations at which the sum total price of \$8105.00 was made up, that the following represented the amount so paid:

- (a) \$4305.00 for flood and construction easement over and across 2.87 acres of land hereinabove described;
- (b) \$3800.00 for damages to onion crop planted and growing on the foregoing land.

At the conclusion of Mr· Hickey's statement he was then and thereupon authorized to conclude said purchase and that upon the execution of a good and sufficient title thereto with all of the stipulations therein to be included and the preparation of all necessary conveyances, there should be a voucher by the District issued for the payment aforesaid sum total of \$8105.00, payable to the order of the said Socrates Klidas, Penelope Klidas, a widow, and Alexander Klidas. On motion of Director Hill, seconded by Director Pier, Mr· Hickey was clothed with the authority to bring the negotiations for such purchase to completion on behalf of the District. All of the Directors voting aye thereon.

6.

The attention of the Board was then directed by the Presi-

dent to the subject of the negotiations that had been conducted for a considerable period of time between the United States Government on the one hand, and the District on the other, concerning exchange of lands between the two bodies.

It appeared from the records in the office of the District, and also from such exchange of correspondence, that when World War Two had ceased the District then sought to regain the lands thus had been temporarily granted to the Federal Government, because the war itself had ceased, and, moreover, the Federal Government no longer used or employed the lands as a Marine Training Base near Eagle Mountain Lake where such lands were situated. Then, again, by virtue of a decree of the Federal Court, in the taking of the land for such temporary uses by the Federal Government, it was recited in such decree that when the use of such lands by the Federal Government had teminated, the Court reserved jurisdiction in such event to restore the lands to the District inasmuch as it was not contemplated that the taking of the land by the Federal Government was a taking of the land in fee simple.

It further appeared that the correspondence and exchange of communications between the Federal Government and the District were conducted through the Eighth Naval District in New Orleans, Louisiana, and at one time, in obedience to communication from the authorities in Washington, instruments had been prepared for the Federal Government to sign under which the land so taken from the District should be released, returned and conveyed over to the District, but that after a substantial interval of time, the authorities in Washington appeared to change their attitude on the question, and Captain

Howard of the Eighth Naval District at New Orleans appeared before the Board of Directors and suggested that inasmuch as the Federal Government owned land in Tarrant County, immediately contiguous to the lands thus taken previously by the Federal Government, that an exchange of such lands should be effected to the end that the District should convey to the Federal Government the major part of the lands taken under the decree of the Federal Government, and as consideration therefore the Federal Government should convey the contiguous land to the District embracing about 241.46 acres of land. It was pointed out to Captain Howard that the authorities in Washington would have no power to convey such lands to the District until authorized so to do by an Act of the National Congress. Following this discussion the matter became dormant to await the action of the Federal Congress to pass such an enabling act as would grant such authority to the Washington officials.

Following this came on the war with Korea, and meantime the negotiations between the Federal Government and District, and the action of Congress on the matter, was suffered to lag, but the District became impatient over the long delays in action, and finally under date of May 27, 1953, an Act of Congress was passed and approved by the President, under which the Washington authorities were granted the power to act and to convey the lands of the Federal Government above mentioned to the District in exchange for the major part of the lands theretofore taken by the Federal Government during World War Two.

Then again further delay ensuæd, and finally on or about the 4th day of January, 1954, the District was advised by the Eighth Naval

District at New Orleans, under the management of Mr. Harwood Shoemaker, that the instruments from Washington were on their way. On examination of the papers when they arrived from Washington, through New Orleans, it was discovered that many objections existed thereto, chief among which was that the instrument of conveyance by the Federal Government was purely a quit-claim, and was not in terms a conveyance, but a mere release of the interest which the Federal Government might have in the property, and on advice of counsel of the District, this objection was immediately urged. In addition to this objection it was found that in the conveyance to the District of its own lands which the Government had previously taken in the Federal Court, it was sought to regulate the level of Eagle Mountain Lake, which was an intrusion upon the power and authority of the Board of Directors in the policy of the District concerning the water level of such lake, and this, too, was regarded as a material objection. When this review of the subject had been concluded, it was resolved unanimously by the Board of Directors, that Sidney L. Samuels, counsel for the District should return such papers to the New Orleans office to be transmitted by such office at New Orleans to Washington, and that a letter from the District through its counsel should be addressed to that effect to the Eighth Naval District, United States Naval Station, New Orleans, Louisiana, containing the objections of the District to the acceptance of the instruments of conveyance proposed to be executed by the Federal Government. This letter was then composed and read before the Board of Directors for its approval. The letter is dated February 15th, 1954, a copy of which is attached in folio to these minutes, and the matters of review in these minutes were

succinctly pointed out and referred to, which letter concluded in declaring that unless these matters of which the District complained should receive prompt attention, and the objections relieved in a new instrument of conveyance by the Federal Government, the District would proceed before the Federal District Court at Fort Worth, Texas, and under the terms of the original decree of taking of the District's land, to move the Court to restore the possession and the attributes of ownership to the District, and thereby restore to the District, by the decree of Court, the property in question.

Upon consideration of all the foregoing matters it was accordingly so resolved by unanimous vote of the Board of Directors, and that the minutes of the Board should record such action.

It was accordingly so ordered.

There being no further business before the Board, the meeting adjourned.



THE INTEREST AND SINKING FUND owns \$1,000,000.00 United States Securities, which are in the Safekeeping Department of the Fort Worth National Bank, Fort Worth, Texas, for which the District holds the Bank's official receipts therefor.

In addition to the \$1,000,000.00 United States Securities mentioned, the INTEREST AND SINKING FUND also owns Eleven (11) Vendor's Lien Promissory Notes of J. D. Craft, bearing date of July 1, 1952, aggregating the sum \$55,000.00; each of said notes being in the principal sum of \$5,000.00, with interest thereon at 4% per annum, payable annually at the office of the District in Fort Worth, Texas, said eleven notes maturing on or before ten, eleven, twelve, thirteen, fourteen, fifteen, sixteen, seventeen, eighteen, nineteen and twenty years.

The eleven (11) notes of J. D. Craft are in the District's office.

On August 18, 1952, Mr. Craft paid the first two (2) notes with interest thereon. On October 20, 1952, Mr. Craft paid the third and fourth notes with interest thereon. On the 28th of October, 1952, Mr. Craft paid the fifth note with interest thereon. On December 22, 1952, Mr. Craft paid the sixth note with interest thereon. On June 2, 1953, Mr. Craft paid the seventh and eighth notes with interest thereon. On August 12, 1953, Mr. Craft paid the ninth note with interest thereon.

We have before us your letter of January 6th. 1954, with enclosures, and we have also your letter of inquiry dated Pebruary 3rd. 1954, in which you refer to your prior letter and bring to our attention the subject of the exchange of lands and the changes made in the draft of the instruments previously transmitted to you and by you in turn to the Federal authorities in Washington.

We have been somewhat delayed in making prompt response to your letter of January 6th because it become necessary. in view of the changes which the Washington office had made in the documents prepared by this office, to lay before the full Board of the District the matter of such changes and their eignificance.

First, we are not inclined to present objection to your leaving out of your conveyance the calculation of the total acreage in the deeds. With the map attached to the instrument the land is sufficiently identified, and computation of acroage would

be a matter of simple arithmetical calculation.

In subdivision A of your letter of January 6th, you make mention of a reservation of easement for impounding and depositing water on Areas "A" and "D". This easement is followed up with a limitation to this effect:

"It is suggested the present mean high vater mark, either natural or artificial, be employed as a practical limitation as that mark proves the using of the field by the Navy."

This change is materially at variance with the understanding between the officers of this District and the officers representing the Bighth Navel District and, therefore, the change as it now appears in the draft of the instrument which was lately prepared by Washington authorities cannot be accepted.

change comes at a very late period of time, as a prior agreement had been made between representatives of this District and those of Washington in which no such restriction was sought to be imposed. To substantiate what we are now saying, and in proof of the correctness of our position, let us refer to your letter of April 18, 1951 addressed to the District, 44.7/88:1m, in which, among other things, you say "the documents and data have received careful consideration and are returned with comments and suggestions for your consideration". You then call to our attention certain trivial changes but nowhere in that letter did you suggest the alteration that is now proposed and which is hereinabove set out.

ed, the documents were then revised to read accordingly. Three years have elepsed since the date of your letter and now for the first time, in the teath of the agreement heretofore mentioned, you or Washington now suggest a change which materially encreaches upon the policy of the District in controlling the level of Ragle Mountain Lake. It is also to be observed that the instrument as we prepared it corresponds with the provision of the Decree in the U. 5. District Court at Fort Worth in which the Federal Government was granted a temporary use of the lands which under the agreement of exchange, the District was to convey to you.

We enclose for your reading a copy of the stipulation that appeared in the Decree of the Federal Court - Civil Suit No. 432 on the Docket of the Court. To make it perfectly obvious, we enclose herewith copy of that part of the decree in which the subject matter of this comment is presented.

It also occurs to us that it is nothing short of an unfair proceeding on the one hand to require a fee simple title to the lands the District is to convey to you, and, on the other hand, that the instrument in which you convey your own land to the District should be limited to a naked quit-claim. A quit-claim, as we understand it, is a release of only such interests as the Government may possess at the time the instrument is executed, so that if the Government has heretofore granted rights on the premises so to be conveyed, although not of record, the District would take subject to such unrecorded interests or conveyences. For example: We

learn there are two persons here who assert interest in the property because of an asserted understanding or agreement with agents of the Covernment. One is Mr. Paul Toulinson, who asserts that he has an instrument in writing from the Government giving him a right to use some of the property which forms a part of the proposed conveyance to the District. You have supplied us with no set of instruments or of title to disclose that we are gotting and manwhile you have grantod, as it would appear from the claims of certain persons, the use of the property or some part thereof. However, if investigation should furnish convincing proof that the Federal Covernment has not granted such uses of the property to outside persons then we should be willing to accept a conveyance with a appealal warranty . that is to say a deed which would warrent as against the Covernment itself or any person or corsons claiming under it. This would not be a general warrenty and would simply make the Covernment protect us as against its previous conveyances to others, if such there be. This to apply only in the event it should develop that the Government, prior to the conveyance to the District, had granted some use in the property to other persons: Your special varranty would in such event protect he only as against such assertions of interest or ownership.

We have been endeavoring ever since the close of World War II to induce the Covernment to reconvey to us the land which it took and used for temporary purposes of that war, and so we have reached this decisation:

If you cannot give us a conveyance good in law to your own properties, then in the name

of justice give us back our own property and we shall be content.

If this is rejused then as a matter of course we shall be obliged to proceed in the U.S. District Court to procure a reinvestment of ownership and possession of our own properties which the Government of the United States has been withholding wrongfully from us over a period of many years.

We return to you the original of the papers, retaining copies for our files.
