Director Hogsett acted in his capacity as President and Director Pier acted as Secretary, whereupon proceedings were had and done as follows:

1.

On motion duly made and seconded the minutes of the meeting held February 15, 1962 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

2.

On motion of Director Pier, seconded by Director Newton, voucher-checks #785 to #823 inclusive, Cedar Creek Construction Fund and voucher-checks #1034 to #1059 inclusive, Maintenance Fund were approved and ordered paid upon receiving the approval and verification of Mr. J. M. Williams, County Auditor, who by virtue of the Statutes is the Auditor of this District as well. All the Directors voted aye thereon.

Mr. Ben Hickey, General Manager, presented bid proposals for purchase by the District of a 1962 Chevrolet Fordor Sedan replacing Unit No. 1-C. The bid proposals exhibited were as follows, to-wit:

Following a tabulation of the proposals, Director Hill made the motion, seconded by Director Pier, that the low bid of Jack Williams Chevrolet Company, as submitted on District specifications, in the net amount of \$1,195.75, be accepted. This meeting with approval of all Directors it was so ordered.

Mr. Ben Hickey, General Manager of the District, requested authority for the District to enter into Contract for the purchase of the following described tracts of land required for the Cedar Creek Reservoir, and on the following basis for payment, to-wit:

- (a) Tract No. 8 Mrs. C. E. Skiles even exchange of two (2) acres more or less (Tract No. 10 Teetz).
- (b) Tract No. 171 Ben Lacy 180.85 acres more or less @ \$120.00 per acre.
- (c) Tract No. 314 Miss Jewell Watkins et al 550 acres more or less @ \$100.00 per acre.
- (d) Tract No. 112 L. F. Beets 4.64 acres more or less @ \$100.00 per acre.
- (e) Tract No. 173 Ralph Lacy 69.5 acres more or less @ \$110.00 per acre + \$3,476.50 for complete severance and damages.

Following a detailed presentation of the Tracts, and upon recommendation of management of the District, Director Hill, seconded by Director Newton, moved that the District be authorized to enter into Contract for the purchase of the above described tracts and on the basis as shown. This meeting with the approval of all Directors, it was so ordered.
