Director Hogsett acted in his capacity as President and Director Pier acted as Secretary, whereupon proceedings were had and done as follows:

1.

On motion duly made and seconded the minutes of the meeting held November 23, 1962 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

2.

On motion of Director Pier, seconded by Director Newton, voucher-checks #1815 to #1859 inclusive, Cedar Creek Construction Fund; voucher-check #141 Cedar Creek Revenue; voucher-checks #1748 to #1771 inclusive, Maintenance Fund; voucher-checks #128 and #129 Construction Fund and voucher-check #138 Interest and Sinking Fund were approved and ordered paid upon receiving the approval and verification of Mr. J. M. Williams, County Auditor, who by virtue of the

Statutes is the Auditor of this District as well. All the Directors present voted age thereon.

3.

Mr. Ben Hickey, General Manager of the District, requested authority for the District to enter into Contract for the purchase of the following described tracts of land required for the Cedar Creek Reservoir, and on the following basis for payment, to-wit:

- (a) Tract No. 316 Bessie W. Fuller 32.16 acres more or less @ \$100.00 per acre - 9.5 acres more or less Easement @ \$50.00 per acre.
- (b) Tract No. 179 Edna Mae Landrum et al 63.8 acres more or less 43.5 acres @ \$150.00 Fee 21.3 acres @ \$110.00 Fee
- (c) Tract No. 355 W. E. Clamon et al 47 acres more or less @ \$150.00 per acre.

Mr. Hickey also requested authorization for the District to enter into Contract for the purchase of Pipeline Right-of-Way Easements for the Cedar Creek Project, on the following basis for payment, to-wit:

- (a) Tract No. N-16 Louis Wolens 437.80 rods @ \$3.00 per rod \$1,313.40.
- (b) Tract No. E-92 Alvin H. Babovec 94.50 rods @ \$4.00 per rod \$378.00.
- (c) Tract No. N-12 Wm. A. Littleton 1/7 Int. 55.50 rods @ \$3.00 per rod \$23.80.
- (d) Tract No. N-19 John L. Benton 38.80 rods @ \$3.00 per rod \$116.40.
- (e) Tract No. T-73 J. M. Moore 65.50 rods @ \$5.00 per rod \$327.50.
- (f) Tract No. E-55 J. T. Almond 120.00 rods @ \$4.00 per rod \$480.00.

Following a detailed presentation of the Tracts and Pipeline Right-of-Way Easements, and upon recommendation of management of the District, Director Newton, seconded by Director Hill, moved that the District be authorized to enter into Contract for the purchase of the above described tracts and pipeline right-of-way easements and on the basis as shown. This meeting with the approval of all Directors, it was so ordered.
