MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD ON THE 10TH DAY OF JUNE, 1964 AT 10:00 A. M.

The call of the roll disclosed the presence or absence of Directors as follows:

Also present were Messrs. Marvin C. Nichols from the firm of Freese, Nichols and Endress, Consulting Engineers for the District, John M. Scott General Counsel for the District and Ben Hickey General Manager of the District.

Director Hogsett acted in his capacity as President and in the absence of Director Boggess, Director Pier acted as Secretary, whereupon proceedings were had and done as follows:

1.

On motion duly made and seconded, the minutes of the meeting held May 28, 1964 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

2.

On motion of Director Pier, seconded by Director Newton, voucher-checks #1412 to #1454 inclusive, Maintenance Fund and voucher-checks #1616 to #1657 inclusive, Cedar Creek Construction #15

Fund and voucher-check #130 Interest and Sinking Fund were approved and ordered paid upon receiving the approval and verification of Mr. J. M. Williams, County Auditor, who by virtue of the Statutes is the Auditor of this District as well. All the Directors voted aye thereon.

3.

President Hogsett stated that in accordance with the terms of a contract dated January 27, 1960, between Freese, Nichols and Endress, Consulting Engineers for the District, and this District, for engineering services in regard to the \$19,500,000.00 Cedar Creek Project, the following letter had been received from the Consulting Engineers, to-wit:

Mr. Ben F. Hickey General Manager Tarrant County Water Control and Improvement District No. 1 Fort Worth, Texas RE: Cedar Creek Reservoir Relocation of T. & N.O. R.R.

Dear Mr. Hickey:

In accordance with your letter of June 3, 1964, regarding the use of other Fort Worth engineers in connection with the relocation of the T. & N.O. Railroad through the Cedar Creek Reservoir, we propose to use the services of J. Weldon Hunnicutt, Structural Engineer, for the design of bridges and other structures required for the project. Mr. Hunnicutt would be responsible for foundation investigations, preparation of plans and technical specifications, and general consultation during construction. In connection with structures, Freese, Nichols and Endress would perform all field surveys, incorporate plans and specifications into other documents for construction of the relocated facility, and supervise construction, For his services, we would pay Mr. Hunnicutt a fee of two and one-half (2-1/2%) percent

of the construction cost of the structures, estimated at approximately \$200,000, which payment to him would be made from the fee received by us from the District.

We propose to do other work in the preparation of plans and specifications for the awarding of a contract for the relocation of the railroad and would supervise construction. Compensation to our firm for the complete relocation would be on the same basis as set forth in the existing contract.

If this arrangement is agreeable to the District, it is requested that you indicate below your approval and this letter can serve as a supplemental agreement as provided by the contract.

President Hogsett requested Mr. Marvin C. Nichols, Consulting Engineer for the District, to present his (Mr. Nichols')

proposed recommendation to the Directors for a settlement with the Texas Power & Light Company's facilities that will need to be relocated or altered because of the affect of the Cedar Creek Reservoir construction; whereon, Mr. Nichols gave a detailed review of each item listed in his letter of recommended settlement, to-wit:

Dear Mr. Hickey:

Re: Texas Power & Light Co. Facilities in Cedar Creek Reservoir

Pursuant to your request, we have reviewed the estimate of T.P.&L. to relocate, rearrange and/or alter electrical distribution and transmission facilities located within the area of the Cedar Creek Reservoir, Henderson County, Texas as transmitted to you under date of October 2, 1963 by P. G. Wallace, Vice President in charge of Engineering.

The Item Numbers discussed below are the same as used by Mr. Wallace and are shown on the attached map, marked Exhibit A, prepared by T.P.&L. and transmitted October 2, 1963.

The Items have been grouped into Categories which are as follows:

#### CATEGORY I.

. . /

<u>Description</u>: Property served as a customer by Company with facilities existing prior to construction of lake is now situated in lake basin, has been acquired by District and service is no longer desired by District.

Items: 21, 22, 23 and 24.

Policy: Pay Company labor costs to remove facilities, Company

to retain salvaged material. Dead end and anchor or dry land. Pay Company for anchor materials and labor to dead end.

## CATEGORY II.

<u>Description</u>: Existing facilities affected only to a limited extent, if at all, by construction of lake.

Items: 11, 27 and 29.

<u>Policy</u>: On Item 11 pay Company labor and materials to make one span of 500 feet across arm of lake.

On Item 27, pay Company to install new 40' poles across Lacy and Cedar Creek bottoms between elevation 322 on each side of creeks. Line to be maintained on present ROW.

No work considered necessary on Item 29.

(It is pointed out that lake level will be maintained at elevation 317' for the next 8 or 10 years. Permanent level is 322'.)

### CATEGORY III.

<u>Description</u>: Facilities built since lake construction commenced in order to serve new customers and developments resulting from the construction of the lake.

Items: 1, 2, 3, 4, 5, 6 and 20.

<u>Policy</u>: No payment will be made to Company to relocate, rearrange or alter facilities in order to continue service to these customers.

#### CATEGORY IV.

<u>Description</u>: Relocation of 138 KV transmission line across arm of lake.

Item: 28.

<u>Policy</u>: Pay Company to remove existing line and install new line as shown on Exhibit A attached, with credit allowed for salvage of old line.

CATEGORY V.

#15<sup>8</sup>

<u>Description</u>: Facilities built prior to lake construction which must be relocated, rearranged or altered in order to continue service.

<u>Items</u>: 7, 8, 9, 10, 12, 13, 14, 15, 16 and 17.

<u>Policy</u>: Pay Company labor cost removing 8, 9, 13, 14, 16 and 17. Pay Company constructing 7, 10, 12 and 15. Allow District credit salvaged materials 8, 9, 13, 14 and 16.

## CATEGORY VI.

<u>Description</u>: Substantial new construction of distribution line required through an unserved territory, together with conversion of existing distribution line to a higher voltage.

Items: 18 and 19.

Policy: No payment for Item 18 as line is being upgraded from 2.4 KV to 7.2 KV. Pay Company 1/2 of construction cost of Item 19 depreciated 25% to approximate present condition of system. Construction of Item 19 will make new service available along 34,950' of 7.2 KV line.

### CATEGORY VII.

<u>Description</u>: Relocate existing 24 KV transmission line from Trinidad to Mabank.

Items: 25,26, 30 and 31.

Policy: Pay Company for construction of 14.77 miles of 24 KV transmission line to same standards as existing line from new substation 17,000' east of Malakoff to 3,000' south of Mabank as shown on Exhibit A. - Item 25. Depreciate cost 25% to approximate condition of present 24 KV line. Pay Company to move existing substation and re-- assemble at new location - Items 30 and 31. Pay Company labor for removal of existing 24 KV line from Trinidad to a point approximately 10,000' south of Mabank with credit for salvage to be given District -Item 26.
