1. This Board of Directors has found and hereby finds:
That an election has heretofore been held resulting favorably to
the issuance of bonds and the levy of a tax for the payment thereof,
that said bonds were issued, sold and delivered and the tax therefor
levied and that the flood control works, improvements and facilities
for which said bonds were issued were constructed, and that it is
now necessary to make certain modifications in said improvements
and to purchase and construct further and additional improvements
in the District.

This Board of Directors, upon its own motion further finds that it is necessary to make additional improvements and

purchase additional property in order to carry out the purpose for which this District was organized, and to best serve the interests of said District.

2. That an election be held in said Tarrant County Water Control and Improvement District No. 1 on the 12th day of November, 1964, at which election the following propositions shall be submitted:

## PROPOSITION NO. 1

"Shall the Board of Directors of Tarrant County Water Control and Improvement District No. 1 be authorized to issue the bonds of said District in the sum of \$13,575,000, maturing serially in such installments as may be fixed by the Board of Directors, the maximum maturity being not more than 35 years from their date, bearing interest at a rate or rates not to exceed 5% per annum, for the purpose of further improving the flood control facilities of said District as shown in Item I of said Engineers' Report, secured by the levy of an ad valorem tax upon all taxable property within such District sufficient in amount to pay the interest on such bonds as it accrues and to redeem and discharge such bonds at maturity?"

## PROPOSITION NO. 2

"Shall the Board of Directors of Tarrant County Water Control and Improvement District No. 1 be authorized to issue the bonds of said District in the sum of \$3,015,000, maturing serially in such installments as may be fixed by the Board of Directors, the maximum maturity being not more than 35 years from their date, bearing interest at a rate or rates not to exceed 5% per annum, for the purpose of further improving the flood control and water supply facilities of said District as shown in Item 2 of said Engineers' Report, to-wit: Improvements to Bridgeport Dam, secured by the levy of an ad valorem tax upon all taxable property within such District sufficient in amount to pay the interest on such bonds as it accrues and to redeem and discharge such bonds at maturity?"

3. The election precincts of this District are hereby defined to be the same as the election precincts of the County of Tarrant, State of Texas, except as hereinafter provided with respect to certain areas of the County of Tarrant, which are not within the

boundary of this District and the number assigned to each District precinct shall be the same as the number assigned to the same County of Tarrant precinct, except that in the areas where not all of the County precinct is within the boundary of this District that portion of the County precinct within the boundary of this District shall be a part of each District precinct as designated below and a map on file at the polling place shall inform the Judge and the voters as to the area within the boundary of this District. Said election shall be held at each of the following polling places within said District, and the following named persons are hereby appointed as presiding officer of said election:

(As Recorded in Permanent Files of District)

- 4. That said election shall be held under the laws governing general elections except as otherwise provided by the provisions of Chapter 268, Acts of the Fifty Fifth Legislature, 1957, Regular Session, and only legally qualified electors residing within said District who own taxable property in said District and who have duly rendered the same for taxation shall be qualified to vote.
- 5. The ballots of said election shall have written or printed thereon the following:

# PROPOSITION NO. 1

"FOR THE ISSUANCE OF THE GENERAL FLOOD CONTROL BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREFOR"

"AGAINST THE ISSUANCE OF THE GENERAL FLOOD CONTROL BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREFOR"

## PROPOSITION NO. 2

"FOR THE ISSUANCE OF BRIDGEPORT DAM FLOOD CONTROL AND WATER SUPPLY IMPROVEMENT BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREFOR"

"AGAINST THE ISSUANCE OF BRIDGEPORT DAM FLOOD CONTROL AND WATER SUPPLY IMPROVEMENT BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREFOR"

Each voter shall mark out one of the above expressions in each proposition, thus leaving the other as indicating his vote on each proposition.

6. Notice of said election shall be given under the hand of the President and Secretary of the Board of Directors, stating the maximum amount of bonds to be issued and the proposed maximum interest thereon, the maximum maturity date of said bonds and the time and places of holding said election. Said notice shall be published, as required by law, in a newspaper having general circulation in the County in which said District is located. Said notice further shall contain substantially the propositions to be voted upon and a summary of the engineers' estimate of the cost of the proposed improvement as shown by said engineers' report on file in the office of the District as approved by the Board of Directors.

"AGAINST THE ISSUANCE OF BRIDGEPORT DAM FLOOD CONTROL AND WATER SUPPLY IMPROVEMENT BONDS AND THE LEVY OF AD VALOREM TAXES IN PAYMENT THEREFOR"

6. Notice of said election shall be given under the hand of the President and Secretary of the Board of Directors, stating the maximum amount of bonds to be issued and the proposed maximum interest thereon, the maximum maturity date of said bonds and the time and places of holding said election. Said notice shall be published, as required by law, in a newspaper having general circulation in the County in which said District is located. Said notice further shall contain substantially the propositions to be voted upon and a summary of the engineers' estimate of the cost of the proposed improvement as shown by said engineers' report on file in the office of the District as approved by the Board of Directors.
