PROGRAM D - CLEAR FORK

- (a) Tract No. 22 W. W. Wilson, University Drive and Holtzer Drive - 16,824 square feet in fee, Lump Sum Settlement @ \$68,000.00.
- (b) Tract No. 23a A. L. Baker 33,810 square feet + on Holtzer Drive, in fee @ \$47,650.00.
- (c) Tract No. 24 Baker Brothers Nursery Holtzer Drive and Rogers Road - 95,607 square feet +, in fee @ \$169,500.00.

WEST FORK

(d) Tract No. 142 - James C. Gau - A portion of Lot 9, Trinity Gardens - in Easement @ \$300.00.

BRIDGEPORT

(e) Tract No. 1 - W. Roy Hastings et al - 505 acres' +__ Wise County, Texas and improvements in fee @ \$118,625.00.

CEDAR CREEK
