On motion of Director Penry, seconded by Director Newton, voucher-checks #3429 thru #3502, inclusive, Maintenance Fund; voucher-checks #881 thru #894 inclusive, Program D Construction; voucher-checks #2956 thru #2996 inclusve, Cedar Creek Construction; voucher-checks #189 and #190, Interest and Sinking Fund and voucher-checks #153 thru #155 inclusive, Revenue Fund were approved and ordered paid

upon receiving the approval and verification of Mr. J. M. Williams, County Auditor, who by virtue of the Statutes is the Auditor of this District as well. All the Directors voted age thereon.

President Hogsett presented the following letter, to-wit:

Gentlemen:

In response to yours of February 3, 1966 and in view of our overall negotiations and understandings with the State Highway Department, we recommend that the District grant an easement for Highway purposes over 3-17/100 acres of the referenced area situated below elevation 325 feet mean sea level and convey to the State of Texas in fee 7-23/100 acres of the referenced land situated above elevation 325 feet mean sea level in exchange for two parcels of State of Texas land one containing 0-29/100 acres and the other 0-015/1000 acres being a total of 0-305/1000 acres required for the railroad relocation.

Nichols gave a general report on the status of a study now being conducted by the Texas Water Development Board in the search for plans most feasible in the transfer of water from one river basin to another; and in substance stated that this District would be affected, especially by the proposal now being studied to bring Cypress and Sulphur River water to the Tarrant-Dallas County area, and that at a later date he (Mr. Nichols) would present his recommendation to the Directors for their study.
