On motion of Director Hudson, seconded by Director Penry, voucher-checks #8502 thru #8579, inclusive, Payroll - \$21,975.65; voucher-checks #1266 thru #1274, inclusive, Revenue Fund - \$7,676.63; voucher-checks #5981 thru #6004, inclusive, Maintenance Fund - \$29,817.14; voucher-checks #1828 thru #1845, inclusive, Construction Fund - \$36,245.46 and voucher-check #256, Interest and Sinking Fund - \$61.07 were approved and ordered paid upon receiving the approval

and verification of Mr. J. M. Williams, County Auditor who by virtue of the Statutes is the Auditor of this District as well. All Directors present voted age thereon.

Following a discussion of the request and upon a motion by Director Hudson, seconded by Director Penry with all Directors voting aye, approval of the sale and assignment was so granted.

4.

Management of the District presented, and recommended, a proposal for consideration by the Directors whereby the District would acquire a sixty (60) foot wide right of way containing 3.75 acres of land more or less located in the J. Wilcox Survey No. 53, Abstract No. 1709, in Tarrant County, Texas and being more particularly described by a metes and bounds description as filed in District records, same being right of way necessary for ingress to a certain tract now owned by District; said right of way to be exchanged by Grantor for a tract owned by District containing 6.6 acres more or less in above listed Survey and as described by a metes and bounds description recorded in District records.

Mr. Ben Hickey, General Manager, presented an appraisal prepared by Mr. Ross Jones, reflecting a fair market value of the 3.75 acres <u>+</u> right of way tract to be \$1,500.00 per acre; and the fair market value of the 6.6 acres <u>+</u> tract owned by the District to be \$100.00 per front foot of lake frontage or a value of \$37,500.00 for the 6.6 <u>+</u> acres. Mr. Hickey recommended, that following the requirements as set forth in the laws governing the District in the sale of land, the District sell to Mr. 0. Yandell the above described 6.6 <u>+</u> acres for a lump sum of \$37,500.00, and that the District buy from Mr. Yandell, et al, the above described 3.75 <u>+</u> acres on the basis of \$1,500.00 per acre with Mr. Yandell paying the balance

(\$31,875.00) in ten (10) equal annual consecutive payments with an interest rate of seven (7%) percent per annum payable annually as it accrues.

Following a discussion Director Penry, seconded by Director Newton, made the motion that upon approval of General Counsel for the District the above recommended sale and purchase be now authorized. Upon a vote taken all Directors voted age and it was so ordered.

President Hogsett presented to the Directors the Monthly Financial Report regarding receipts and disbursements for Program "A", "B" and "D" and Cedar Creek Project, for the month of April, 1968 from the Auditor of the District, which was ordered accepted and placed in the District's Records.
