The call of the roll disclosed the presence or absence of Directors as follows:

Also present were Messrs. John M. Scott General Counsel for the District, Ben Hickey General Manager of the District, Marvin C. Nichols and Leary Eeds Engineers for the District and C. R. Mertschien of the Texas Water Rights Commission.

Director Hogsett acted in his capacity as President and Director Penry acted as Secretary, whereupon proceedings were had and done as follows:

On motion duly made and seconded, the minutes of the meeting held May 31, 1968 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

2.

On motion of Director Hudson, seconded by Director Penry, voucher-checks #8580 thru #8688, inclusive, Payroll; voucher-checks #6005 thru #6067, inclusive, Maintenance Fund; voucher-checks #1846 thru #1856 inclusive, Construction Fund and voucher-checks #1275

thru #1317 inclusive, Revenue Fund were approved and ordered paid upon receiving the approval and verification of Mr. J. M. Williams, County Auditor, who by virtue of the Statutes is the Auditor of this District as well. All Directors present voted aye thereon.

3.

President Hogsett stated that at this time he would call upon Mr. Marvin C. Nichols representing the Consulting Firm of Freese, Nichols and Endress, Engineers with whom the District held a contract agreement for the furnishing of engineering services to the District for the construction of certain spillway additions to the Eagle Mountain Spillway, to give a progress report on the project; whereon Mr. Nichols introduced Mr. Leary Eeds as associate of his firm and Mr. C. R. Mertschien an engineer representing the Texas Water Rights Commission.

Mr. Nichols reviewed in detail the work performed to this date, by Whittle Construction Company and Associates, from August 14, 1967 date of execution of construction contract, and during the lengthy detailed report, Mr. Nichols discussed a report, prepared for Freese, Nichols and Endress by Fruco and Associates, Inc., Engineers and Architects of St. Louis, Missouri, and signed by Chas. I. Mansur, President and W. T. Turnbull, Consultant.

Following a general discussion of the Eagle Mountain Spillway Project, President Hogsett requested that the Board be kept fully advised concerning the progress of the Spillway Project.
