Following a discussion of the bid proposals and upon recommendation of management of the District, Director Hudson, seconded by Director Boggess, made motion that upon approval by Counsel for the District, and proper State Agencies if required, the three (3) recommended firms as hereinabove listed by letters from the Consulting Engineers for the District be accepted. Upon a vote taken all Directors voted aye and it was so ordered.

4.

A request from the City of Fort Worth for an easement

right for installation of a sanitary sewer line by the City, as described by detail in the permanent records of the District and being located in the Brookside area of Program D. Following a discussion and upon recommendation of management of the District, it was the unanimous order of the Directors, that upon approval by Counsel for the District, that the easement right be granted to the City of Fort Worth for the purposes stated.

5.

President Hogsett presented to the Directors the Monthly Financial Report regarding receipts and disbursements for Program "A", "B" and "D" and Cedar Creek Project, for the month of July, 1968 from the Auditor of the District, which was ordered accepted and placed in the District's Records.

6.

An instrument prepared by Counsel for the District setting forth a partial release of an easement heretofore granted the District without charge for certain flood control uses, not now required by the District, approved by the Corps of Engineers and recommended by management of the District, covering approximately 131/1000 of an acre from the Easement as recorded in Vol. 2703, Page 10 of the Deed Records in Tarrant County, Texas was presented for the consideration of the Directors.

Following a discussion Director Newton made a motion, seconded by Director Boggess, that the release be executed by the District; whereon all Directors voted age and it was so ordered.

Mr. John M. Scott, General Counsel for the District, informed the Directors that under Article 5400a V.A.T.S., a readvertising for bid proposals for an Oil and Gas Lease on lands owned by the District, authorized for advertising at the meeting held on February 19, 1968, and the bids received being declared as not acceptable at the meeting held on May 16, 1968, would be necessary; whereupon Director Boggess made a motion, seconded by Director Hudson, that the District be now authorized to advertise for bid proposals on the leasing for oil, gas and other minerals of the District's mineral interest in the following tracts, and being more particularly described in the permanent records of the District, to wit: 129.18 acres more or less in G. W. Roper Survey, 357.93 acres more or less in G. W. Roper and J. Fitzgerald Surveys, all in Wise County, Texas. Upon a vote taken all Directors voted aye and it was so ordered.

There being no further business before the Board of Directors, the meeting adjourned.
