Director Newton acted in his capacity as President, and Director Geren acted as Secretary, whereupon proceedings were had and done as follows:

The minutes of the meeting held April 3, 1978 were read and approved; and it was accordingly ordered that such minutes be placed in the permanent files of the District.

> RE: Cedar Creek Lake Pump Station-Pumping Equipment

Dear Mr. Hickey:

Bids were received on April 27, 1978 for furnishing pumping equipment for the Lake Pump Station with two alternates, namely for either one pump or three pumps, together with the appropriate appurtenances including motor controllers and pump control valves. Three bids were received for pumps and controllers and two for control valves, a summary of which is shown below.

The lowest and best bid on the pumps, motors and motor controllers

is that of Johnston Pump Company in the amount of \$678,667 for three units. *It should be noted that the price for the motor controls fo three (3) units includes three (3) motor starters, one (1) tie breaker, one (1) main breaker, and one (1) auxilliary compartment, all of which are required for the ultimate electrical installation in order to have a dual incoming service and the desired flexibility. The bid for only one unit included one (1) motor starter only, and it would be connected by temporary cable connections, and would have to be moved later when the additional starters and breakers were purchased and installed.

The lowest and best bid on the pump control valves is that of Allis-Chalmers Corporation in the amount of \$128,130.00 for three valves.

The pumps, motors and motor control equipment offered by Johnston is identical to that which now exists in the pump station, so this would simplify the maintenance, operation, and servicing of the equipment, as well as minimize the stock of spare parts necessary.

The District has the option to buy one unit or three units at this time. However, it is felt that it will be to the District's advantage to buy all three units at this time in order to take advantage of the obvious price savings, and be assured of getting equipment which is compatible with the existing equipment. These three units will fully develop the ultimate capacity as planned for this pump station.

We, therefore, recommend the award to two contracts to cover the equipment for three pumping units as follows:

Johnston Pump Co. \$678,667.00

Allis-Chalmers Corp. 128,130.00

TOTAL AWARD \$806,797.00

Please advise us of the District's action on this recommendation, and if they concur we will prepare the Contract Documents for execution by the Supply Contractors and the District.

Following a review of the bids offered in accordance with specifications by the District, Director Geren moved, seconded by Director Penry and unanimously approved, that with the recommendation of management of the District, the bid of Hi-Way Machinery Company in the amount of \$102,470.00 be accepted and that the District sell the 1967 Gradall in the amount of \$20,000.00 cash; and that the low bid of International Harvester Company in the amount of \$2,115.00 be accepted.
