MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD ON THE 15TH DAY OF SEPTEMBER, 1981 AT 9:00 A. M.

The call of the roll disclosed the presence or absence of Directors as follows:

Director Newton acted in his capacity as President and Director Alexander as in his capacity as Secretary, whereupon proceedingts were had and done as follows:

1.

On motion duly made and seconded, and with assurance from management that all requirements of law relating to the "open meeting" law had been met, the minutes of the meting held August 12, 1981 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

2.

Director Geren moved and the motion was seconded by Director King and unanimously approved that the following list of vouchers be approved and paid:

The Clark tract will be acquired in trade on a value for value basis for a 450 acre tract to be purchased by the District from Homer Paul Bonner @ \$595.00 per acre, Navarro County, Texas and a 560 acre tract to be purchased from the Ash, Teer and Winberg Trust, First National Bank of Corsicana, Texas @ \$550.00 per acre, Navarro County, Texas.

Following a detailed presentation of the tracts, and upon recommendation of management of the District, Director

Thornton moved, seconded by Director Alexander, that the District be now authorized to enter into contract for the purchase of the above described tracts and on the basis as shown. This meeting with the approval of all Directors it was so ordered.

4.

President Newton presented a proposed agreement between the State of Texas (Highway Department) and Tarrant County Water Control and Improvement District Number One for the construction of a detour roadway that will carry the FM Road 488 traffic while a portion of FM Road 488 is removed during construction of the dam and spillway at the Richland Project; and in reviewing the agreement, copy attached, management stated that recommendations heretofore made by the District were incorporated in the presented agreement, whereon Director Geren moved, seconded by Director Thornton and unanimously approved, that with recommendation of management and engineers of the District the agreement be accepted.

5.

The following statement, prepared by the Actuarial Agent for the District's Pension Plan (heretofore furnished the Directors for their consideration), to wit:

AMENDED AND RESTATED PENSION PLAN
OF TARRANT COUNTY WATER CONTROL AND
IMPROVEMENT DISTRICT NUMBER ONE

ADMINISTRATIVE DECISION NUMBER ONE

We, the Board of Directors of the Tarrant County Water Control and Improvement District Number One, desire to clarify the Early Retirement provisions of the Amended and Restated Pension Plan as adopted on February 25, 1981. The purpose of this Administrative Decision Number One is to provide a mathematical method for the

calculation of an Employee's Early Retirement Benefit. The adoption of this mathematical method is deemed to be necessary so that all Employees will be treated equally and fairly. The method for determining an Employee's Early Retirement Benefit shall be as follows:

An Employee, upon his Early Retirement under the provisions of the Amended and Restated Pension Plan, shall be entitled to receive his "Amount Accrued". The "Amount Accrued" shall mean an Employee's estimated projected retirement pension benefit at age 65, as set out under the Amended and Restated Pension Plan, multiplied by a fraction, the numerator being the Employee's total full months of Credited Service as of the date of his Early Retirement and the denominator being the total full months of Credited Service the Employee would have had if he had continued in employment until age 65. The "Amount Accrued" shall be payable in monthly installments for five (5) years certain and life thereafter with the first payment to begin the last day of the calendar month in which the Employee attains the age of 65. purposes of estimating an Employee's projected retirement pension benefit, the Employee's October 1st Compensation immediately preceding Early Retirement shall be used for the Compensation in all future years.

Payment of an Employee's "Amount Accrued" may begin prior to age 65 with the District's approval. IF payment begins prior to age 65, the Employee shall receive the "Actuarial Equivalent" of the "Amount Accrued". The "Actuarial Equivalent" is defined to be the amount of pension benefit that can be paid at a different time other than at age 65 for the same anticipated cost to the District as the "Amount Accrued". In the case of Early Retirement, the "Actuarial Equivalent" of the "Amount Accrued" is assumed to be a reduced pension benefit. Between the ages of 60 and 65 inclusive, this reduced pension benefit or "Actuarial Equivlent" of the "Amount Accrued" shall be equal to the "Amount Accrued" reduced 1/180th for each month the starting date of the first payment precedes age 65. Between the ages of 55 and 60 incluisve, this reduced pension benefit or "Actuarial Equivalent" of the "Amount Accrued" shall be equal to 2/3rds of the "Amount Accrued" reduced 1/360th for each month the starting date of the first payment precedes age 60. If the starting date of the first payment precedes age 55, the reduced pension benefit or "Actuarial Equivalent" of the "Amount Accrued" shall be equal to 1/2 of the "Amount Accrued" reduced actuarially assuming a 5% annual interest rate with mortality for both sexes to follow the 1971 Group Annuitants Mortality Table for males.

We hereby adopt and register our approval of this Administrative Decision Number One which shall be effective as of October 1, 1980, on this 15th day of September, 1981.
