On motion duly made and seconded, and with assurance from management that all requirements of law relating to the "open meeting" law had been met, the minutes of the meeting held
May 3, 1982 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

Director King moved and the motion was seconded by Director Alexander and unanimously approved that the following list of vouchers be approved and paid:

SUBJECT: Engine Analyzer

In my opinion, the Sun analyzer is superior to any other analyzer we have seen to date. I recommend that we purchase this unit from the Sun Corporation. I would also like to point out that this analyzer will service the entire Water District equipment pool from Bridgeport to Richland-Chambers. It is portable and sturdy enough to withstand movement to other District shops.

We have been studing the idea of using one of these analyzers for some time now and have been investigating these units thoroughly. The newer vehiciles have gone to computers and electronic ignitions instead of points...and this fact makes it hard to determine problems related to these parts. We feel that this analyzer will pay for itself in saved parts and time before three years.

# SUN ELECTRIC CORPORATION:

The Sun Performance Analyzers are used by the City of Fort Worth, T.C.J.C., T.E.S.C.O., Tune-Co., and Goodyear Stores. All claim good records. The Sun Company has bid their best analyzer to us for \$17,110.20, with all attachments. We will receive 32 hours for all of ourmechanics, plus all the in-shop training we need. Sun offers service on equipment performed at the District garage within eight hours of break down. Also, if the analyzer is at Bridgeport or Cedar Creek servicing equipment and breaks down, Sun will go there to fix the problem.

#### F.M.C. INTELLIGENT ANALYZER:

The F.M.C. Intelligent Analyzer is the next best analyzer in my opinion. But, it does not perform as many tests as the two others. This analyzer is priced at \$18,136.00. I cannot recommend it because it is not portable and could not be moved from shop to shop easily. Training and service is limited.

## ALLEN TEST PRODUCTS

The Allen Smart Scope is priced at \$20,320.00. This machine is not an analyzer, it would run 205 tests on an engine and if it found anything wrong, it would refer you to a book t figure out the problem.

Following a detailed review and with recommendation of management of the District, Director King moved, seconded by Director Thornton and unanimously approved, that the District accept the bid proposals submitted by the Sun Electric Corporation

in the amount of \$17,110.20; Clemons Tractor Company in the amount of \$11,918.59; and Saginaw Implement Company in the amount of \$6,974.00 as per District specifications.

5.

Mr. Bill Hilliard presented to the Directors the agreement/contract between the State of Texas and the District for State engineeering, field inspection, pavement marking and signing on the relocated FM Road 488 in Freestone County at the Richland Creek Project. The relocation of FM488 will be included in the main dam and spillway contract. This agreement insures upon acceptance of the relocated road and bridge by the State the assumption of responsibility for maintenance. The agreement was approved by District counsel and recommended by Freese and Nichols, Inc. Consulting Engineers for the District.

Following a more detailed discussion, including an amendment to a previously discussed draft relating to the frequency of inspections, Director King moved, seconded by Director Thornton and unanimously approved that the District be now authorized to enter into agreement/contract with the State of Texas for the stated purposes and remit to the State Treasurer, Account Trust Fund No. 927 the amount of \$32,000.00 as full compensation under the terms of said agreement/contract.

Mr. Bill Hilliard presented for review and consideration the construction plans for Contract III, Dam and Spillway, Richland Creek Project. It was stated that Director Thornton, in his capacity as engineering advisor, had been briefed in detail

prior to this meeting. Changes to the plans were noted and explained. A letter of transmittal and recommendation for approval from Freese and Nichols, Inc. is attached and made a part of these minutes. A statement of recommendation from the General Manager of the District is also attached as per the request of the Board.

Following the discussion of the documents and plans, and contingent upon the written recommendation for approval by Management, Director Thornton moved, seconded by Director Alexander and unanimously approved the contract plans and documents for Contract III, Richland Creek Project.
