Reference is made to our letter of February 11, 1983, submitting the proposal of Southwestern Laboratories to conduct welding inspection of the gates for the captioned project. Pursuant to your request, we have received two additional proposals; one from Maxim Engineers, Inc., and the other from Trinity Engineering Testing Corporation for the welding inspection work. These proposals are attached for your inspection.

Freese and Nichols furnished drawings, specifications and gave a verbal description of the work and time commitments to the three laboratories. They, in turn, determined the manhours required to perform the assignment. Based on the laboratories' interpretation of the work, the estimated cost to perform these services are as follows:
