Also in attendance were Lee Freese and Ernest Clement, representing Freese and Nichols, Inc. and Raymond Trotter, representing the Mildred Independent School District. Director Thornton presided as President and Director Shannon acted as Secretary, whereupon proceedings were had and done as follows:

On motion made by Director Henderson and seconded by Director Newton, and with the assurance from management that all requirements relating to the "open meetings" law had been followed, the minutes of the meeting held November 3, 1986, were unanimously approved and it was accordingly ordered that such minutes be placed in the permanent files of the District.

Mr. James L. Strawn, Director of Operations for the District, presented the recommendation from Freese & Nichols, Inc. concerning the award of contracts for the purchase of the necessary pump units and control valves for construction of the Richland-Chambers Pipeline.

Bids were received on October 23, 1986 for furnishing Pumping Units and Pump Control Valves for the Richland Creek Water Supply System.

Three bids were received for furnishing the Pump Control Valves as follows:

The bid of Willamette Valve is the lowest and best bid received and we recommend an award of contract to them in the amount of \$295,600.00 plus the cost for services of the Manufacturer's Representative, estimated at \$10,400.00 (4 trips at \$1,700.00 per trip and 8 days at \$450.00 per day), for a total amount of \$306,000.00.

Six (6) bids were received for furnishing Vertical Turbine Pumping Units for the Lake Pump Station and a complete tabulation of the bids, evaluation, and data submitted is attached. Following a summary of the three lowest bids for the pumps and motors:

In evaluating the bids, consideration was given to the guaranteed overall operating efficiency of the units and the lowest total of Worthington was actually the highest evaluated cost. The lowest evaluated cost was the alternate bid of Ingersoll-Rand, as shown above, using a General Electric motor.

The bid of Ingersoll-Rand, however, is not in compliance with the requirements of the Specifications in that they cannot test this size motor by the dynamometer method specified.

We therefore recommend an award of contract to Borg Warner in the amount of \$1,432,246.00, which includes the cost to spare parts and field services specified. Their pumps would be furnished with Louis Allis motors which will be tested as specified.

Proposals were also received for furnishing three (3) additional identical pumps without motors at the District's option. These three pumps would be for use with steam turbine drives in the event that steam power is made available to the District in the near future, and their purchase is at the District's option.

We do not recommend an award at this time for purchase of the three (3) pumps without motors since it has not been determined that steam power will be available or if the presently designed pump station will accommodate the steam turbine drives. Borg Warner, however, has furnished a Letter dated December 1, 1986, and a copy is included herewith indicating the conditions under which the District could delay the acceptance of their bid for the three (3) additional pumps without motors.

Six (6) bids were received for furnishing three Horizontal Centrifugal Pumping Units for the Booster Pump Station, and a complete tabulation of the bids, evaluation, and data submitted is attached. Following is a summary of the three lowest bids:

The bid of Patterson was the lowest price but the bid of Goulds was the lowest evaluated cost. However, the information submitted with their bid indicated that the pump which they were offering would not operate satisfactorily over the full range of pumping conditions which were specified. It would require a higher net positive suction head that is available at the pump station in order to perform satisfactorily.

The low bid of Patterson Pump Company is also the lowest evaluated cost of the <u>acceptable</u> pumps. We, therefore, recommend an award of contract to Patterson in the amount of \$415,200.00 for the three (3) pumping units, which includes the cost of spare parts and field services specified.

Based upon the letter of recommendation, Lee Freese explained the methods used for making the evaluations on the

proposals submitted by the various manufacturers. Based upon the recommendation and explanaion of Mr. Freese, management of the District concurred with the recommendations of Freese and Nichols dated December 1, 1986.

With the recommendation of management and with the assurance that all legal requirements of bid solicitation had been followed, Director Shannon moved to award contracts to the successful bidders as outlined below:

Mr. Strawn next introduced Mr. Ray Trotter,
Superintendent of the Mildred Independent School District.
Mr. Trotter presented a proposal for a cooperative effort between
the District and the School District in providing additional
facilities. Mr. Trotter claimed that the impact of the
Richland-Chambers Reservoir has resulted in a reduction of revenue
for the School District. He stated that this will not correct
itself until the development caused by the lake begins. This growth
is not predicted to have a profound positive effect on the School
District's revenues for several years.

Mr. Thornton thanked Mr. Trotter for his presentation and stated that the District would soon determine what role the District should play with regards to such a cooperative effort.

4.

Mr. Strawn next presented a request for authorization to award the contract for the salvage of the Delhi Pipeline at Richland-Chambers Reservoir. Bids were solicited requesting quotations on two methods of salvage: the sale of pipe in place or the removal/stockpile method. Based upon the review of the bids submitted, management recommended that the contract for the salvage of the Delhi Pipeline be awarded to P. K. Pipe & Tubing, Inc. It is recommended that their bid of \$118,320.00 for the sale of pipe in place be accepted.

With the recommendation of management, Director Newton moved to authorize the award of the contract for the salvage of the Delhi Pipeline to P. K. Pipe & Tubing, Inc. based upon their bid of \$118,320.00 for sale of the pipe in place. Director Henderson seconded the motion and the vote in favor was unanimous.

5.

Mr. Strawn next requested authorization for the immediate fee transfer of the original 13,700 acres of mitigation land from the District to the Texas Parks and Wildlife Department. This process is in accordance with the stipulations set forth in the U. S. Army Corps of Engineers "404 Permit" which allows the construction of the Richland-Chambers Reservoir.

In addition, the immediate transfer will assist the District in the negotiations concerning public access points around the reservoir.

With the recommendation of management, Director Newton moved to authorize the immediate fee transfer of the 13,700 acres of mitigation land on the downstream side of the Richland-Chambers Dam to the Texas Parks and Wildlife Department. This will be subject to negotiations on public access points between the District and Texas Parks and Wildlife. Director Henderson seconded the motion the vote in favor was unanimous.

6.

Consideration of a resolution outlining an agreement between the District and Texas Parks and Wildlife Department calling for the construction of public access facilities at Richland-Chambers Reservoir was deferred.

7.

Steve Christian, Real Property Manager for the District presented several land matters for consideration by the Board of Directors.

7A.

Mr. Christian requested authorization to commence eminent domain proceedings to acquire pipeline right-of-way easements over the following tracts upon failure of the following owners to accept final offers enumerated as follows:

- 0.01 acre in easement for \$200.00 including all surface damages from Douglas Tiller, out of the J. M. Campbell Survey A-185, Navarro County, Texas, District Tract #4N-5.
- 2) 4.88 acres in easement for \$4,880.00 from Gene L. Thomas et al out of the heirs of Fannie Russell Survey A-683, Navarro County, Texas, District Tract #4n-16.

- 3) 0.14 acre in easement for \$500.00 including all surface damages from Christopher L. Hoffma, out of the heir of Fannie Russell Survey A-683, Navarro County, Texas, District Tract #4N-17.
- 4) 19.73 acres in easement for the appraised value of \$14,800.00 from Martha Sloan Lewis et al out of the J. P. Hardin Survey A-386 and the S. P. Bailey Survey A-81, Navarro County, Texas, District Tract #4N-30.
- 5) 0.15 acre in easement for the appraised value of \$500.00 including all surface damage from P. H. Sloan out of the J. P. Hardin Survey A-386 and the S. P. Bailey Survey A-81, Navarro County, Texas, District Tract #4N-28.

with the recommendation of management, Director Henderson moved to authorize the commencement of eminent domain proceedings to acquire easements over the above listed tracts upon the failure of the owners to accept the final offers. Director Shannon seconded the motion and the vote in favor was unanimous.

7C.

Mr. Christian next requested approval for the acquisition of 6.86 acres in easement necessary for the construction of the Richland-Chambers Pipeline. Consideration will be paid in the amount of \$10,290.00 for the easement and includes payment for surface damages.

With the recommendation of management, Director Shannon moved to authorize the acquisition of 6.86 acres in easement from Blake Gillen, out of the William J. Dabney Survey A-233, Navarro County, Texas, District Tract #4N-14. Consideration will be in the amount of \$10,290.00 for the easement and surface damages. Director Henderson seconded the motion and the vote in favor was unanimous.

7C.

Mr. Christian next requested authorization to acquire the following tracts necessary for the construction of Richland-Chambers Reservoir.

- 1) 0.47 acre in easement for \$500.00 from Marvin M. White, Jr., out of the John White Survey, Navarro County, Texas, District Tract #441. (See attached plat)
- 2) 50.43 acres in fee @ \$2,000.00/acre, 4.04 acres in easement @ \$500.00/acre from Preston W. Bonner, et ux, Verna Bonner, out of the D. H. Love Survey A-510, Navarro County, Texas, District Tract #309. (See attached memo and plat)
- 3) 73.31 acres in fee @ \$2,000.00/acre, 6.76 acres in easement @ \$500.00/acre from Doris Bonner Eakes, out of the D. H. Love Survey A-510, Navarro County, Texas, District Tract #378. (See attached memo and plat)

With the recommendation of management, Director Shannon moved to authorize the acquisition of the listed tracts as enumerated above. Director Henderson seconded the motion and the vote in favor was unanimous.

7 D.

Mr. Christian next called for a consent agenda in considering the renewal of the following four land leases.

1) 42 Acres - Lot 9 of the District's - O. L. Marshall Subdivision, located in the H. S. Williams Survey, A-1960, west side of Eagle Mountain Lake, northwest Tarrant County. Currently leased for grazing by Mr. J. P. Eagleton. The terms of the lease will be for one year for five dollars per acre.

- 2) 3 Acres, more or less, a portion of Lot 4, Sycamore Heights Addition. This property is located north of the Trinity River and east of Beach Street. The term of the lease will be for one year for consideration of \$200.00. The Lessee is Trinity Wood Industries. They use the property for storage of lumber and machinery, as it is situated adjacent to their facility.
- 3) 28.97 Acres, J. Nix Survey, Abstract No. 478, Freestone County. This property is located n the Mitigation area below the Richland-Chambers Dam, but is not part of the land to be deeded to the State of Texas.Mr. Joseph Satagaj, Sr., has been leasing the subject property for grazing cattle on a yearly basis since 1983 and would like to continue. The term of the lease will be for one year for five dollars per acre.
- 4) Lease to Mr. Gary Freeman for one year at \$7.00 per acre; \$539.00. The rental on this grazing lease is currently \$6.50 per acre, or \$500.00 per year. The lease is 77 acres, located in the John Baker Survey A-17, Kaufman County.

With the recommendation of management, Director Henderson moved to authorize the renewal of the above listed leases upon the terms described. Director Newton seconded the motion and the vote in favor was unanimous.

7E.

Mr. Christian next presented for consideration the matter of a request by the Azle Independent School District to purchase, in fee, 55.69 acres from the District's land holdings at Eagle Mountain Lake for expansion of their school facilities. No action was taken at this time. Staff was however instructed to pursue developing a market value basis for continuing negotiations with the Azle Independent School District.

7F.

Madeline Robson, Special Services Manager for the District, along with Mr. Christian, presented a request for authorization to acquire a 2.56 acre tract located directly adjacent to the Western Division Central Maintenance Base in Fort Worth.

Ms. Robson stated that the Western Division Central Maintenance Base will require the ability to expand its facilities in the near future. This tract is the only land available which is adjacent to our current facility. James K. Norwood has appraised the property at \$2.00 SF, however the owner is willing to sell to us at \$1.50 SF to avoid possible future condemnation.

With the recommendation of management, Director Shannon moved to authorize the acquisition of the 2.56 acre tract more or less, adjacent to the Central Maintenance Facility for future expansion from Mr. Cameron Kerran at the negotiated price of \$1.50 per square foot. Director Henderson seconded the motion and the vote in favor was unanimous.

Mr. Strawn next requested authorization to sell the following used equipment to the high bidders who participated in bidding which occured on November 14, 1986.
