With the assurance from management that all requirements of the "open meetings" laws had been met, Director Henderson convened the meeting.

1.

On a motion made by Director Campbell and seconded by Director Sparks, the Directors unanimously voted to approve the minutes from the meeting held May 21, 1996. It was accordingly ordered that such minutes be placed in the permanent files of the District.

There were no persons of the general public requesting the opportunity to address the Board of Directors.

3.

The Vice President and presiding officer next called an executive session under Chapter 551.071 of the Government Code to consider pending or contemplated litigation.

Upon completion of the executive session, the Vice President reopened the meeting.

With the recommendation of management, Director Sparks moved to ratify a resolution executed on July 3, 1996 authorizing the District to protest the issuance of TNRCC Water Quality Permit Number 03867 to Griffin Industries. Director Newby seconded the motion and the vote in favor was unanimous.

RESOLUTION OF BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE AUTHORIZING PROTEST OF PROPOSED TEXAS NATURAL RESOURCE CONSERVATION COMMISSION WATER QUALITY PERMIT NO. 03867 (GRIFFIN INDUSTRIES)

WHEREAS, Tarrant County Water Control and Improvement District Number One ("District") is the owner of Certificate of Adjudication No. 08-5035, as amended, issued by the Texas Natural Resource Conservation Commission's ("Commission") predecessor agency;

WHEREAS, Certificate of Adjudication No. 08-5035 authorizes the District to impound water in Richland-Chambers Reservoir, and to divert and use water therefrom for municipal and other purposes;

WHEREAS, Griffin Industries, Inc. has requested a water quality permit to authorize handling and treatment of waste, among other things, from a rendering facility proposed by that company to be located within the near watershed of Richland-Chambers Reservoir, in the general vicinity of the Cities of Corsicana and Angus Texas;

WHEREAS, issuance of Water Quality Permit No. 03867 as proposed to be issued by the Texas Natural Resource Conservation Commission to Griffin Industries, Inc. presents a danger of detrimental impacts to water quality in Richland-Chambers Reservoir and its contributing watershed area;

WHEREAS, it is appropriate and necessary for the District to participate as a party in administrative and court proceedings related to proposed Water Quality Permit No. 03867 in order to protect the District's interest in water quality.

NOW, THEREFORE, be it resolved by the Board of Directors of the District that: The General Manager of the District is hereby authorized and directed on behalf of the Board of Directors to protest granting of proposed Water Quality Permit No. 03867; to appear and arrange for the appearance of persons representing the District at administrative hearings, appeals if necessary, and other legal proceedings on the proposed permit; and on behalf of the Board of Directors to otherwise pursue the District's protest of the permit as proposed.

With the recommendation of management, Director Sparks moved to adopt a resolution authorizing application to the TNRCC to amend the Benbrook Reservoir Permit. Director Campbell seconded the motion and the vote in favor was unanimous.

RESOLUTION OF BOARD OF DIRECTORS

AUTHORIZING APPLICATION TO
TEXAS NATURAL RESOURCE CONSERVATION COMMISSION
FOR AMENDMENT OF BENBROOK RESERVOIR PERMIT

WHEREAS, Tarrant County Water Control and Improvement District Number One ("District") is the owner of Permit No. 5157 issued by the Texas Natural Resource Conservation Commission's ("Commission") predecessor agency on November 2, 1987;

WHEREAS, Permit No. 5157 authorizes the District to divert water allocated to City of Fort Worth, to City of Weatherford and to Benbrook Water and Sewer Authority; to divert water to customers in Tarrant County; to use Benbrook Reservoir for terminal storage for rediversion; and to overdraft Benbrook Reservoir on a non-priority basis for municipal purposes;

WHEREAS, the Tarrant County Regional Water Supply Facilities Contract was entered into as of June 11, 1992, by and among the District, City of Fort Worth, City of Arlington, City of Mansfield, Trinity River Authority of Texas, City of Weatherford, and Benbrook Water and Sewer Authority, calling on the District to include Benbrook Reservoir as part of the District's water supply system and to build a pipeline between Benbrook Reservoir and the District's Cedar Creek and Richland-Chambers Reservoirs pipelines;

WHEREAS, pursuant to Permit No. 5157, the District maintains by contract with the U.S. Army Corps of Engineers the right to use 72,500 acre-feet of storage in Benbrook Reservoir;

WHEREAS, the Tarrant County Regional Water Supply Contract further defines the rights and responsibilities of the contracting parties with regard to operation of Benbrook Reservoir:

WHEREAS, to further implement the District's operations from Benbrook Reservoir, it is necessary to change the points of diversion and outfall of water at the reservoir, and to increase the rate of diversion of water from those points and rates specified in Permit No. 5157;

WHEREAS, to accommodate the water supply needs of City of Weatherford, it is necessary to identify the point(s) of diversion specified for City of Weatherford in Permit No. 5157:

WHEREAS, to accommodate the water supply need of Benbrook Water and Sewer Authority, it is necessary to identify the point(s) of diversion specified for the Authority in Permit No. 5157;

WHEREAS, it is in the District's best interest to obtain the authority to supply an amount of water from Benbrook Reservoir also for irrigation and industrial purposes;

WHEREAS, the District proposes to file and pursue with the Commission an application to amend Permit No. 5157 to change various points of diversion and rate of diversion and to add irrigation and industrial as authorized purposes of use.

NOW, THEREFORE, be it resolved by the Board of Directors of the District that:

1. The General Manager of the District is hereby authorized on behalf of the Board of Directors to execute such application as is necessary to be made to the Commission to amend Permit No. 5157.

2. The General Manager of the District is hereby authorized and directed on behalf of the Board of Directors to file such application as is necessary to amend Permit No. 5157, to appear and arrange for the appearance of persons representing the Distinct at the hearings and other proceedings on the application before the Commission, and otherwise to direct prosecution of the application on behalf of the Board of Directors.

Brush A-93 located in Wise County, Texas to the high bidder, Top-Way Properties, Inc., for the mining and production of sand and gravel under the following terms:

- Ten (10) year term
- Stockpiling of top soil for City of Newark
- \$25,000.00/yr. advance minimum royalty
- Graduated royalty payments beginning with \$1.10/cu. yd. for year one and increasing \$0.02/cu. yd. each year of the lease

Further, that R. Steve Christian is authorized to execute the lease and all other documents necessary to close this transaction. Director Newby seconded the motion and the vote in favor was unanimous.

With the recommendation of management, Director Sparks moved to authorize the District to consent to the sale of the property described below to Fort Worth Housing Finance Corporation., for the total purchase price of \$8,375.62 being the lesser of the market values specified in the judgments of foreclosure or the total amount of the judgments against the properties. Further, the District is authorized to abide by the decision of the City of Fort Worth, trustee under the foreclosure judgment, concerning the public or private nature of the sale and the ultimate choice of Grantees. It is further requested that R. Steve Christian be granted

authority to execute all documents necessary to close these conveyances. Director Newby seconded the motion and the vote in favor was unanimous.

With the recommendation of management, Director Newby moved to authorize the commencement of eminent domain proceedings to acquire 1.37 acres in pipeline easement, being part of that certain 23.93 acre Southwest Christian School tract situated in the William W. Warnell Survey, A-1616, Claiborne Johnson Survey, A-849 and the John F. Heath Survey, A-641, in Tarrant County, Texas, from Southwest Christian School, Inc. necessary to construct the Benbrook pipeline, upon the failure of the owner to accept the offer authorized during the earlier executive session. Further, R. Steve Christian shall be granted authority to execute all documents necessary to close this transaction. Director Sparks seconded the motion and the vote in favor was unanimous.

12.

With the recommendation of management, Director Campbell moved to accept the following lowest conforming bids for equipment to be funded by the Richland - Chambers Construction Fund and to reject the sole bid submitted by Future Equipment in the amount of \$35,346.00 for one (1)1996 Industrial 4WD Tractor with Scrapper.

• \$24,276.00 submitted by Classic Chevrolet of Grapevine, Texas for one (1) 1996 4WD Crew Cab LWB Pickup; and

• \$59,260.00 submitted by Darr Equipment Company of Fort Worth, Texas for one (1) 1996 Industrial 4WD Tractor with Backhoe Loader.

Director Sparks seconded the motion and the vote in favor was unanimous.

13.

With the recommendation of management, Director Campbell moved to accept the low bid in the amount of \$274,200.00 submitted by Kirkpatrick & O'Donnell of Irving, Texas for One (1) 1996 98,000 LB Hydraulic Excavator. Funding for this purchase is to be allocated in the Fiscal Year 1997 General Fund Budget. Director Sparks seconded the motion and the vote in favor was unanimous.

14.

With the recommendation of management, Director Sparks moved to approve the signature rebuild of one (1) 1982 Caterpillar D6D LGP Dozer Unit #08-035 by Darr Equipment Company for an amount not to exceed of \$70,000. Funding for this purchase is to be appropriated from the Capital Projects Fund and to be reimbursed by the General Fund. Director Newby seconded the motion and the vote in favor was unanimous.

With the recommendation of management, Director Newby moved to award the remainder of the Vegetation Management contract to next lowest bidder Chem Spray North, Inc. of Arlington, Texas. Director Campbell seconded the motion and the vote in favor was unanimous.

16.

With the recommendation of management, Director Campbell moved to award the purchase of \$32,855.00 of stream gauging equipment from Sutron. Funding for this purchase is to be

provided as Follows: \$24765.00 from the General Fund and \$8,090.00 from the Revenue Fund.

Director Newby seconded the motion and the vote in favor was unanimous.

With the recommendation of management, Director Newby moved to approve the following list of vouchers for the months of May and June, 1996.

After a brief discussion and following Vice President Henderson relaying the sentiments of President Shannon in absentia, Director Campbell moved to authorize all formal steps required to change the name of the Tarrant County Water Control and Improvement District Number One to the Tarrant Regional Water District to be effective on October 1, 1996 and contingent upon the required order authorizing this change from the Texas Natural Resource Conservation Commission. Director Newby seconded the motion and the vote in favor was unanimous with all Directors present including the Chair voting aye.

There being no further business before the Board of Directors, the meeting adjourned.
