All present were given the opportunity to join in reciting the Pledge of Allegiance.

On a motion made by Director Sparks and seconded by Director Leonard, the Directors unanimously voted to approve the minutes from the public hearing held on December 14, 2007

and the meeting held on December 18, 2007. It was accordingly ordered that these minutes be placed in the permanent files of Tarrant Regional Water District.

Dick Fish announced that Save Eagle Mountain Lake has proposed that they take the shore along Eagle Mountain Park as their clean-up area during the Eagle Mountain Lake Clean-up and that they would also like to clean this area as part of the Adopt-a-River program.

4.

Fran Burns of the Trinity River Environmental Education Society (TREES) presented an award to the Water District for the clean-up and educational accomplishments achieved through the Trinity River Trash Bash.

5.

Walt Agnew of the Strategic Energy presented an award recognizing the Water District as the first Texas water agency to achieve green status for energy consumption.

With the recommendation of management, and after Terry Kile of Deloitte and Touche, LLP, the Water District's auditors, made a presentation, Director Leonard moved to approve the Annual Financial Report by Deloitte & Touche, LLP. Director Stevens seconded the motion and the vote in favor was unanimous.

Randall Harwood of the City of Fort Worth made a presentation regarding the proposed merging of the Gateway Park Ecosystem Restoration and Recreation Plan with the Trinity River Vision Central City Flood Plan.

With the recommendation of management and the Technical Committee, Director Lane moved to grant Madeline Robson authority to renew routine annual hardware/software maintenance and support agreements. Director Sparks seconded the motion and the vote in favor was unanimous.

With the recommendation of management and the Land Committee, Director Sparks moved to approve the sale of the following described tracts of land to Kemp Lakeside Investors, L.L.C. (KLI) for the appraised value of \$70,000 with the agreement that KLI will return a flowage easement to TRWD to elevation 330 feet above mean sea level across the tracts surrounding Tract 2.

Eight parcels of land totaling 11.33 acres and described as Tracts # 1, 2, 4, 6, 8, 10, 12, and 14, situated in the E. Higdon Survey, A-197, Kaufman County, Texas as shown on the attached plats.

In addition, R. Steve Christian is granted authority to execute the deed and all other documents necessary to complete this transaction. Director Lane seconded the motion and the vote in favor was unanimous.
