## MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT REGIONAL WATER DISTRICT HELD ON THE 20<sup>TH</sup> DAY OF MAY 2008 AT 9:30 A.M.

The call of the roll disclosed the presence of the Directors as follows:

Also present were James Oliver, Alan Thomas, Darrel Andrews, Laura Blaylock, Ken Brummett, Steve Christian, Wesley Cleveland, Woody Frossard, Sheila Johannessen, David Marshall, Wayne Owen, Kari Schmidt, Paula Stewart, Sandy Swinnea and Mike Witthaus.

Also in attendance were George Christie, General Counsel for Tarrant Regional Water District (the Water District); Dick Fish of Save Eagle Mountain Lake; Ron Lemons of Freese and Nichols, Inc.; Michael Siciliano of Standard Renewable Energy; Kathy Berek of HDR; Jeff Salavarria of Frost Bank; Max Baker of the Fort Worth Star Telegram; Judd Pritchard of Trinity River Communications; and Earl Alexander.

President Henderson convened the meeting with the assurance from management that all requirements of the "open meetings" laws had been met.

1.

All present were given the opportunity to join in reciting the Pledge of Allegiance.

2.

The Water District contracted with the Tarrant County Elections Administrator to conduct the joint election for Water District directors and the Tarrant County special bond election on May 10, 2008.

The Tarrant County Elections Administrator has counted, summarized and delivered the sealed precinct returns to Nancy L. King as the Representative of the Presiding officer of the canvassing authority, President Henderson. President Henderson then tendered to the Board as the canvassing authority the sealed precinct returns and a tabulation stating for each candidate the total number of votes received in each precinct and the sum of the precinct totals.

The tabulation reflects that Vic Henderson, Hal S. Sparks III, and Jack R. Stevens were duly elected to the Board and the Board certified them as duly elected members of the Board of Directors of Tarrant Regional Water District, and declared the election results to be formally canvassed as shown on the tabulation:

According to the results of the election for three (3) Tarrant Regional Water District Board of Directors, Victor W. Henderson was administered the Oath of Office by Martha V. Leonard, Secretary Pro-Tem. Hal S. Sparks III and Jack R. Stevens were administered the Oaths of Office by Victor W. Henderson, President.

4.

On a motion made by Director Stevens and seconded by Director Sparks, the Directors unanimously voted to approve the minutes of the meeting held on April 15, 2008. It was accordingly ordered that these minutes be placed in the permanent files of Tarrant Regional Water District.

5.

Dick Fish of Save Eagle Mountain Lake had many favorable comments regarding the Eagle Mountain Park including a couple who has already hiked all the trails.

6.

With the recommendation of management, Director Leonard moved to approve an interlocal agreement with the Trinity River Authority, North Texas Municipal Water District and the City of Dallas to analyze freshwater inflow needs. Funding for the Water District's portion of the cost of this study is included in the FY 2008 Revenue Fund Budget in the amount of \$141,600. Director Sparks seconded the motion and the vote in favor was unanimous.

With the recommendation of management and committee as noted, Director Lane moved to approve operations and maintenance expenditures as noted below:

With the recommendation of management and the Construction Committee, Director Leonard moved to approve the purchase of solar power system equipment for the new Information Technology and Engineering facility from Standard Renewable Energy at a cost of \$1,471,930. Funding for this purchase is included in the FY 2009 General Fund Budget. Director Lane seconded the motion and the vote in favor was unanimous.

9.


With the recommendation of management and the Construction Committee, Director Leonard moved to release the retainage and final payment on the contract with Archer Western Contractors Ltd. for the Arlington Outlet Expansion Project in the amount of \$120,933.24. Funding for this project is included in the 2006 Bond Fund. Director Stevens seconded the motion and the vote in favor was unanimous.



With the recommendation of management and the Construction Committee, Director Leonard moved to approve a contract with Apache Ecological Services for aquatic planting services for the Wetlands Construction Project for the estimated cost of \$76,050.30. Funding for this project is included in the 2006 Bond Fund. Director Lane seconded the motion and the vote in favor was unanimous.

The President and presiding officer next called an executive session at 10:29 a.m. under V.T.C.A., Government Code, Chapter 551.071 to consider pending or contemplated litigation - Oklahoma Water

Resources; and under Chapter 551.072 to consider oil and gas issues.

Upon completion of the executive session at 11:01 a.m., the President reopened the meeting.

With the recommendation of management and the Oil and Gas Committee, Director Lane moved to


approve a lease with Dale Property Services, LLC for the bid of \$94,665.00, 25 percent royalty, three (3)

year primary term for the Water District's mineral interest in approximately 6.311 acres as follows:

Ray Survey, Abstract No. 1353, more practically described by metes and bounds in that certain Warranty Deed dated May 7, 1987 by and between Mike A. Myers, as Grantor and the Tarrant County Water and Improvement District No. 1, as Grantee, recorded in Volume 8968, Page 476 of the Deed Records, Tarrant County, Texas.

In addition, Ken Brummett is granted authority to execute the lease and all other documents necessary to complete this transaction. Director Leonard seconded the motion and the vote in favor was unanimous.

With the recommendation of management and the Oil and Gas Committee, Director Lane moved to ratify the oil and gas lease agreement between Robert Anderson Vance and XTO Energy, Inc. dated May 19, 2005 covering the 4.61 and 1.0 acre tracts as shown on the Exhibit below:


