Dick Fish of Save Eagle Mountain Lake recently attended the 2<sup>nd</sup> Eagle Mountain Protection Plan meeting. The next Eagle Mountain Protection Plan meeting will be held in May.

Mark Ernst and Jennifer Owen investigated an underground spring with a red residue and determined the source is a rusting pipe below ground.

Dick Fish announced that he will be speaking at the DIDO Methodist Church regarding Save Eagle Mountain Lake and the lake on Wednesday, February 18, 2009.

Laura Alexander from First Southwest presented the results from the sale of the 2009 Bond issue as follows:

With the recommendation of management, Director Lane moved to approve 100% abatement of taxes on personal property acquired by 4CP, Ltd. after relocating its business from its current location. The relocation was necessary after its current location was acquired by the Water District in connection with the Trinity River Uptown Project. Director Stevens seconded the motion and the vote in favor was unanimous.

With the recommendation of management and the Land Committee, Director Leonard moved to approve a contract with Freese and Nichols, Inc. for the detailed design of Phase I of the Eagle Mountain Twin Points area at a cost not to exceed \$179,348. Funding for this contract is included in the 2009 General Fund Budget. Director Lane seconded the motion and the vote in favor was unanimous.

The agenda item on the proposed agreement between Tarrant Regional Water District and the Northern Trinity Groundwater Conservation District was tabled.

The agenda item on the proposed scope of work to develop a management plan for Northern Trinity Groundwater Conservation District was tabled.

The President and presiding officer next called an executive session at 9:55 a.m. under V.T.C.A., Government Code, Chapter 551.071 to consider pending or contemplated litigation – Oklahoma water resources; and under Chapter 551.072 to consider real property issues.

Upon completion of the executive session at 11:27 a.m., the President reopened the meeting.

With the recommendation of management, Director Sparks moved to modify the survey contract with TranSystems Corporation by adding seven parcels to be surveyed at an additional cost of \$69,240 for a new contract total of \$441,040. Funding for this contract is included in the 2009 General Fund Budget. Director Lane seconded the motion and the vote in favor was unanimous.
