MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT REGIONAL WATER DISTRICT HELD ON THE 20TH DAY OF JULY 2010 AT 9:30 A.M.

The call of the roll disclosed the presence of the Directors as follows:

All present were given the opportunity to join in reciting the Pledge of Allegiance.

On a motion made by Director Stevens and seconded by Director Leonard, the Directors unanimously voted to approve the minutes from the meetings held June 15, 2010 and July 8, 2010. It was accordingly ordered that these minutes be placed in the permanent files of Tarrant Regional Water District.

3.

Dick Fish of Save Eagle Mountain Lake reported that they have started planning early for the Christmas Parade of Lights, which is scheduled for December 4, 2010.

4.

With the recommendation of management and the committees as noted, Director Stevens moved to approve the operations and maintenance expenditure as noted below:

With the recommendation of management and the committees as noted, Director Leonard moved

Director Stevens seconded the motion and the vote in favor was unanimous.

6.

With the recommendation of management and the Construction and Operations Committee, Director Stevens moved to approve \$50,000 reimbursement to Energy Transfer Fuel GP, LLC for the design cost for relocating their gas line that crosses the proposed treated water canal in the Richland-Chambers Phase II Wetlands Project Site. Funding for this cost is included in the Bond Fund. Director Leonard seconded the motion and the vote in favor was unanimous.

7.

With the recommendation of management and the Construction and Operations Committee, Director Leonard moved to approve entering into a contract with University of Texas at Arlington at a cost not to exceed \$134,660 to study the backfill design for the Integrated Pipeline Project. Funding for this contract is included in the Bond Fund. Director Stevens seconded the motion and the vote in favor was unanimous.

8.

With the recommendation of management and the Construction and Operations Committee, Director Stevens moved to approve Engineering Dynamics, Inc. (EDI) to provide engineering consulting regarding pressure pulsation on the Cedar Creek Waxahachie High Capacity Pumps on a time and materials basis in the amount not to exceed \$28,000. Funding for this service is included in the FY 2010 Revenue Fund. Director Lane seconded the motion and the vote in favor was unanimous.

9.

With the recommendation of management and the Construction and Operations Committee, Director Stevens moved to amend the contract with Applied Weather Associates in the amount of \$47,778 to include three additional items required to complete the analysis and project. Funding for this contract is included in the Bond Fund. Director Leonard seconded the motion and the vote in favor was unanimous.

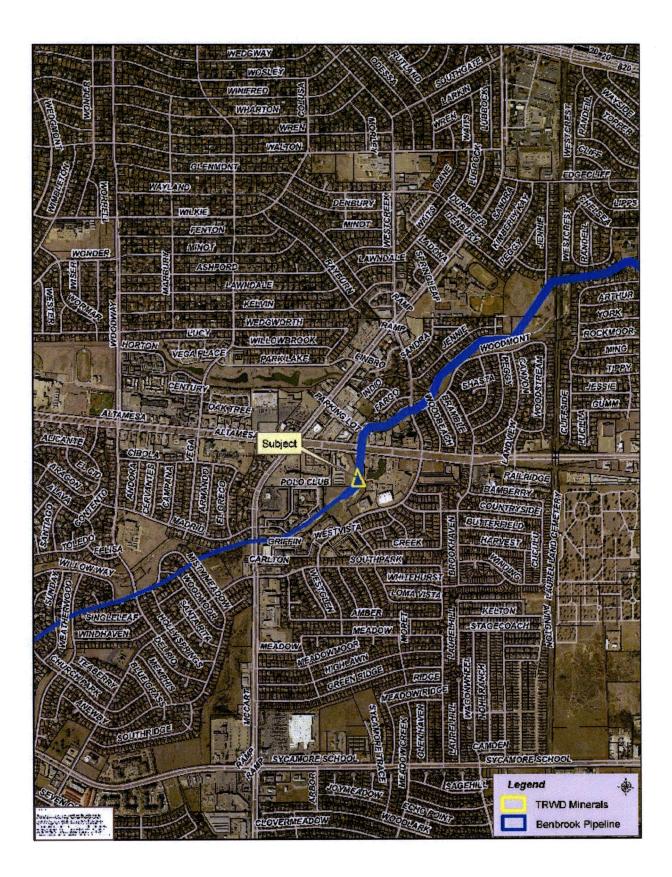
With the recommendation of management and the Construction and Operations Committee, Director Leonard moved to approve \$522,414 for Parsons Brinckerhoff (PB) to continue and complete Phase 4B of the Eagle Mountain Dam Geotechnical and Stability Analysis with field and laboratory investigation, analysis, results, and conclusions. Funding for this contract is included in the Bond Fund. Director Stevens seconded the motion and the vote in favor was unanimous.

11.

With the recommendation of management and the Construction and Operations Committee, Director Stevens moved to approve \$1,373,889 for Parsons Brinckerhoff (PB) to continue and complete Phase 5 of the Eagle Mountain Dam Geotechnical and Stability Analysis with design and construction of remedial measures for Eagle Mountain Dam and levee embankments. Funding for this contract is included in the Bond Fund. Director Lane seconded the motion and the vote in favor was unanimous.

12.

With the recommendation of management and the Oil and Gas committee, Director Lane moved to approve a lease with Dale Property Services, L.L.C. for the bonus bid of \$1,761.50, 25 percent royalty, and a three (3) year primary term for the Water District's mineral interest in and to 0.7046 acres of land described as Block 1, Lot 3B1, out of the Alta Mesa Village Addition, an addition to the City of Fort Worth, Tarrant County, Texas.



In addition, Ken Brummett is granted authority to execute the lease and all other documents necessary to complete this transaction. Director Stevens seconded the motion and the vote in favor was unanimous.

The Board of Directors recessed for a break from 10:12 a.m. to 10:26 a.m.

14.

The presiding officer next called an executive session at 10:27 a.m. under V.T.C.A., Government Code, Section 551.071 to consult with legal counsel on a matter in which the duty of counsel under the Texas disciplinary rules of professional conduct clearly conflicts with Chapter 571, Texas Government Code; to conduct a private consultation with attorneys regarding pending or contemplated litigation; and under Section 551.072 to deliberate the purchase, exchange, lease or value of real property.

Upon completion of the executive session at 11:25 a.m., the President reopened the meeting.

16.

With the recommendation of management and the Trinity River Vision Authority Board of Directors, Director Leonard moved to approve the acquisition, in fee simple, of the property described below and the action of the TRVA Board of Directors recommending such acquisition, the Board of TRWD finding that such property is necessary for the construction of the Trinity River Vision - Central City project. Staff is authorized to acquire the property by negotiated purchase or by the exercise of the power of eminent domain, with title to be held in the name of Tarrant Regional Water District. Funding for this purchase is included in the FY 2010 General Fund Budget. The property is described as:

Fee simple title to the surface estate only of approximately 2.594 acres of land, including improvements, situated in the City of Fort Worth, Tarrant County, Texas and being a tract of land out of the R. Crowley Survey, Abstract No. 313, said tract being conveyed to the Arvin William Turner, Jr. Testamentary Trust by deed recorded in Volume 11458, Page 40 of the Deed Records of Tarrant County, Texas, said tract being more particularly described in the accompanying resolution and in the survey plat attached thereto as Exhibit "A."

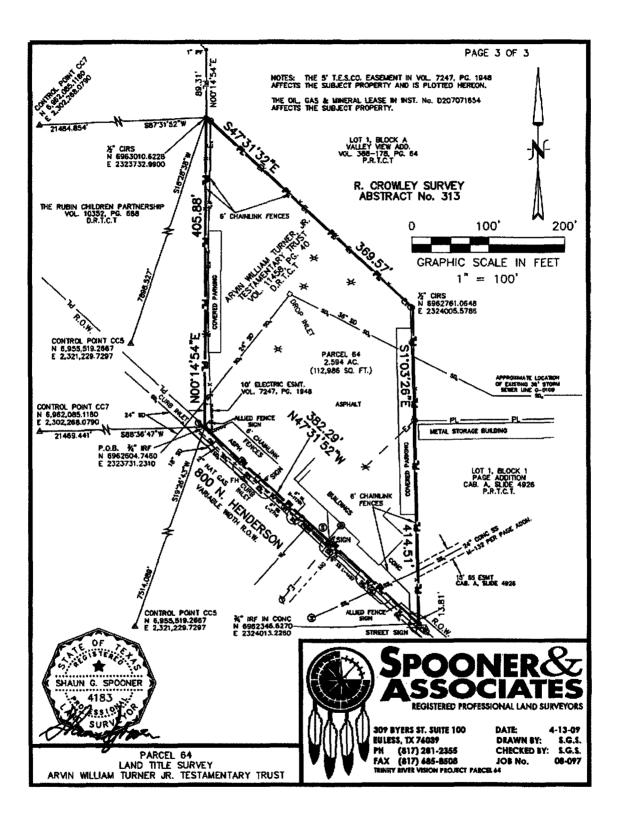
The property adjoins Jacksboro Highway, a variable width street right-of-way which provides apparent access to and from the subject property.
