At a regular meeting of the Board of Directors of Tarrant County Water Improvement District No. 1 with the following members present, to-wit: W. C. Weeks, W. E. Austin, H. M. Hightower and W. E. Bideker; President W. G. Turner being absent Vice President W. C. Weeks presided, when the following proceedings were had to-wit:

This meeting was held for the purpose of inspecting the 75 \$1,000.00 Tarrant County Water Improvement District No. 1 notes, same being the second series of notes issued by the District, the first series having having been returned for cancellation, not having been signed by the President or Secretary of the Board for the reason that the President, W. G. Turner was incapacitated because of illness to sign but one of them.

After said second series was inspected, and found to be in correct form, they were signed, as was provided for in an order by this Board passed on the 31st. day of January 1925, and found of record on page 20 of these minutes by W. C. Weeks, Vice President and W. E. Bideker, Secretary, and after said notes were ordered signed, upon motion of W. E. Austin, and Seconded by H. M. Hightower, which motion unanimously carried, it was ordered that the Secretary deliver said signed notes to the F. and M. National Bank of Fort Worth, Texas, who would forward same with draft for the proper amount attached, to J. L. Arlitt's Austin Bank, at Austin, Texas, who, in turn would inspect the official signatures of the notes and forward them to their attorneys in New York for final inspection and payment.

The following correspondence bearing upon the above transactions and other things incident to the issuance of these short term notes, will be found to read as follows:

We have today sent one of these to the attorneys in New York and suppose that the executed notes will arrive here today or tomorrow so we can send them on to New York for final execution, and if found satisfactory, payment willbe promptly made.

In accordance with your instructions of February 2nd we have delivered to the Farmer's and Mechanics National Bank of Fort Worth, Texas the \$75,000.00 of notes of Tarrant County Water Improvement District No. 1. same having been executed by the proper officials and the seal has also been impressed on each of them.

The F. and M. Bank will register same to your Austin bank with draft attached and also sending letter carrying out your instructions.

Dear Sirs;-

This is to advise that we have recently purchased and are holders of the \$75,000.00 5% note issue of your District, dated December 1st. 1924, due \$15,000.00 February 1st. 1925, \$20,000.00 February 1, 1927; \$40,000.00 February 1st. 1928.

We understand that these notes were voted by your district and issued to defray the expenses of organization of the Dist. etc. preparatory to voting and issuing a permanenent serial Bond Issue and that in the event that the bonds are voted and issued prior to the maturity of the notes, that the notes may be called for payment. Will you kindly advise us just when the notes may be called for payment? We assume that it is only upon an interest paying date and that 30 or 60 days notice would be given. Witl you kindly advise us just what the method would be in case these notes are called for payment and whether any of them could be called prior to maturity, unless they were all called at the same time. Will you also have your secretary make note on his records that we hold this issue, so that we will be notified in the event that they are called for payment, We would also be glad to have you keep us advised of the progress of the Bond issue, whether or not the bonds are voted, and if so, when the time comes to sell them, we would, doubtless we interested in their purchase, although we do not know what amount of bonds you are figuring on putting out.

Gentlemen;-

Replying to yours of February 2nd, will say that in accordance with J. L. Arlitt's instructions, we are today sending by registered mail the \$75,000.00 5 % note issue of Tarrant County Water Improvement Dist. No. 1 same having been properly executed by the District's Officials to said Arlitt's Bank in Austin, Texas where they will be examined by Arlitt, who will then forward same to New York with draft attached.

Replying to your question referring to the maturity of the notes, it is quite possible that it will take from 12 to 18 months for the District to complete the preleminary surveys etc,. and no bond issue will be submitted to the people until this work is completed, and our judgment is that all notes will have been matured before this Bond issue is presented.

In case any of these notes are called for payment, they will all be called at the same time.

Our Secretary will make note on our records that you hold this issue as per yourrequest.

We will be pleased to keep you advised as to the progress of any Bond Issue of the District.
