Dear Sir :-

Replying to your letter of May 19th, and confirming verbal agreement made with Mr. W. C. Weeks and H. M. Hightower, wish to advise that I will make tax Collections for the Tarrant County Water Control and Improvement District No. 1, for a fee of \$2,000.00 per year, beginning October 1st. 1925. This compensation to be deducted from collections made during the months of October, November December and January.

And, this Board of Directors, after due deliberation, accepted the propositions of said Tax Assessor L. A. Freeman and Tax Collector John Pengilly, as Section No. 33, Page No. 94 of the General Laws of Texas, passed by the thirty-ninth Legislature in Regular Session, permits Water Control and Improvement Districts to so employ County Assessors and Collectors to do this work, and to pay them terefor, a "Reasonable Compensation to be agreed upon, which shall not be subject to the fee bill" .And, this Board believing that \$2,000.00 to be paid L. A. Freeman and \$2,000.00 to be paid John Pengilly, for said Assessing and Collect ing the District's taxes is a reasonable fee for such services, chose to have said taxes collected in this manner instead of appointing a special Assessor and Collector as is provided by Sec. 54, page 100 of the General Laws of the State of Texas, as passed by the Thirty-ninth Legislature, pertaining to said Water Control and Improvement Districts. and, it was further agreed that said tax assessorrand tax collector shall be paid monthly during the months of October, November, December and January next. in proportion to the amount of taxes collected for these months.

A general outline of procedure of the engineering work of the District was submitted to the Board of directors by K. Robey, after same had been approved by the State Board of Water Engineers of Austin, and after same had been read and commented upon by the Board and Major John B. Hawley, who was present by invitation, said outline was ordered filed by the Secretary without any action being taken on same.

Major Hawley, after discussing different phases of the engineering work with the Board, made the following written recommendation, to-wit:

Gentlemen:-

After recent studies by Mr. Freese and myself, I am of the opinion that preliminary canal lines should be run down the West Fork Valley, from Lake Worth, to near the Dallas County line.

Mr. Robey's offices are well organized for such survey work, and I recommend that it be undertaken at once.

Data for head levels will be furnished by my office and either Mr. Freese or myself will gladly assist in the field.

whereupon, the Board, upon motion made by W. E. Bideker, and seconded by L. C. Abbott, ordered E. F. McMurtrey, Assistant Manager-Engineer, in K. Robey's absence to have said survey made.

The Board of Directors, desiring to make an inspection of the different lake sites as selected by the engineering forces of the district, decided on Thursday, September 6th to make this inspection trip, and instructed the Secretary to invite Major John B. Hawley to accompany them if convenient.

It was moved by L. C. Abbott and seconded by H. M. Hightower which motion unanimously carried, that absolutely no publicity be given any newspaper reporter, or any one else as to the status of the preliminary work of the District, by any one connected with the District, whether he be officer or employe of the district, except President of the Board, W. C. Weeks, who is hereby designated as mouthpiece for any publicity that the Board may deem expedient, to be given out.

There being no further business at this time the Board adjourned subject to call of President, W. C. Weeks.
