and, after duly considering said propositions, upon motion duly made by L. C. Abbott, which was seconded by H. M. Hightower, said propositions were both accepted, and it is considered, and ordered by this Board, that said L. A. Freeman County Tax assessor be and he is hereby authorized to assess this District's Taxes for the year 1926 for the said sum of \$1,500. to be paid when work is completed upon said L. A. Freeman faithfully performing his duties as said assessor and complying with the law, in such cases made and provided, and that said John Pengilly be and he is hereby authorized to collect this District's Taxes for the year 1926, forethe sum of \$1,500.00 same to be paid out of tax money collected during the month of January 1927, upon said Pengilly faithfully performing his duties as said Tax Collector, giving to this District the re quired bond and otherwise complying with the law in such cases made and provided.

Upon motion duly made by W. E. Bideker, which was seconded by H. M. Hightower, it was ordered that Gillis A. Johnson be paid the sum of \$500.00 for legal services performed for this District

Upon motion duly made by Director L. C. Abbott, and seconded by W. E. Bideker, the following resolution was was unanimously adopted, to_wit:

WHEREAS, The Fort Worth Levee Improvement District No. 1., of Fort Worth, Texas and K. Robey, of Fort Worth, Texas, have each filed bills with this District for moneys expended and services performed for Tarrant County Water Control and Improvement District No. 1 before its organization, and

WHEREAS, it is considered by this Board that such expenditures and services performed before the organization of this District were preliminary and co-operative with many organizations including the Fort Worth Chamber of Commerce, The City of Fort Worth, the City of Arlington and the County of Tarrant, in addition to donations of personal services of many individuals, all of which has been characterized as "Preliminary donations", and,

WHEREAS, it is the sense of this Board that it is without authority to consider the payment of said bills now on file with this Board by said Fort Worth Levee Improvement District No. 1 and said K. Robey; that they rendered their services voluntarily and with authority to act from no one.

THEREFORE, BEIT RESOLVED AND ORDERED, that the payment of said bills be refused and that said Fort Worth Levee Improvement District No. 1 and said K. Robey be so notified.

Major John B. Hawley and Judge Sidney Samuels, Consulting Engineer and Attorney for the District Respectively were present. Judge Samuels expressed his opinion that this district is without authority to pay the amounts in bills rendered by the Fort Worth Levee Improvement District No. 1 and K. Robey, because of the reasons expressed in the resolution above set forth and adopted.

Major Hawley informed the Board that Major Schley, Major Corps of Engineers, V. S. A., and in charge of the Galveston District and his first Assistant, Mr. Gillette would be in Fort Worth soon after July 4th and that he thought that this District ought to provide adequate intertainment for them, whereupon the Board informed Mr. Hawley that every means would be brought to

bear to properly intertain said Distinguished guests, and thanked Mr. Hawley for offering his assistance in doing so.
