Judge Sidney L. Samuels, Attorney for the District was present and stated that he believed that since all lands that are not accessable for irrigation by gravity form the works proposed to be constructed by the District have been duly and legally excluded, that things would be shaped to the end that, that the District could soon proceed unhampered, and that he believed the U. S. Government through its engineer, Maj. J. L. Schley who recently visited and studied our project would look favorably toward extending the District generous aid. Secretary W. E. Bideker reported that he had had the District Depository, the F. and M. National Bank, notify the holders of the \$60,000.00 of short term notes yet unpaid that the money was ready for the payment of the semi-annual interest due AUGUST 1st.

The Secretary was authorized to transfer from the Special Interest Bearing Account of the District in the F. and M. National Bank to the Regular checking account in said bank, \$1,000.00. This was done by order duly passed after a motion for same was made by W. E. Bideker and seconded by L. C. Abbott.
