There was presented to the Board the fact that the presentation filing for water rights with the State Board of Water Engineers relating to the Wise County filing expired on January 6th, 1927. The Secretary was directed to remew the presentation filing to July 6th, 1928.

Moved by W. H. Slay and seconded by H. M. Hightower, that Six hundred dollars (\$600.00) be appropriated for advance expense to defray the expense of W. E. Bideker, Secretary and Ireland Hampton. Further, that they be instructed to proceed to Austin to present to the Legislature of Texas, the special bill providing the manner and means by which the State of Texas would cooperate in providing the flood protection works proposed to be constructed by this district. Motion carried.
