MINUTES OF A CALLED MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE, HELD IN FORT WORTH, TEXAS, ON JULY 6TH, 1927.

Presiding, A. L. Baker, President. Also present directors H. M. Hightower, W. H. Slay, L. C. Abbott and W. E. Bideker, being all the members of the Board. Also present by request, John B. Hawley, of Hawley and Freese, District Engineers, and Sidney L. Samuels and Ireland Hampton, as legal advisors for the District.

President Baker called attention of the Board to the necessity to call an election for acceptance or rejection of the District's plans to be held not later than Saturday, September 24th, 1927. He further pointed out the necessity to again divide the District into election precincts and define the same so as to conform to the boundaries of the District as the same is now defined and bounded. He further stated that he had requested the District Engineers and Counsel to prepare a division of the District into convenient designated and defined election precincts. Major John B. Hawley thereupon presented to the Board, a division of the District into designated election precincts.

After full discussion, there was presented for adoption by the Board, by Director Hightower the following resolution, viz:

"Resolved that the Board of Directors of Tarrant County Water
"Control and Emprovement District Number One, under authority
"granted to them by Section 27 of Chapter 25 of the Acts of The
"39th Legislature of Texas, do divide said District into the
"election precincts, said precincts being hereby designated and
"defined, as is set out in words, in figures and in symbols,
"as written in the tentative plan offered by the engineers and

"counsel. Further that said written designation and defini-"tion of election precincts do be made part of the minutes "of this meeting and a part of this resolution; further that "same be marked for identification, "Exhibit A". "Further be it resolved that all former designations of "election precincts for Tarrant County Water Control and Im-"provement District Number One do be hereby vacated, and "that in said division into election precincts as defined "and designated in said "Exhibit A" do be adopted, and said "District is hereby so divided into election precincts.

Director Abbott seconded the adoption of the foregoing resolution. Upon vote the resolution was unanimously adopted. The President thereupon declared the Board adjourned, subject to call.
