MINUTES OF THE FIRST QUARTERLY MEETING FOR THE YEAR A.D. 1928,

HELD BY THE BOARD OF DIRECTORS OF

TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE

ON MONDAY, MAY 7, A. D. 1928, AT 10 O'CLOCK A. M.

AS REQUIRED BY THE PROVISIONS OF CHAPTER TWENTY FIVE OF THE

ACTS OF THE 39TH LEGISLATURE OF TEXAS

At this meeting President W. R. Bennett presided, and Director W. K. Stripling, as Secretary of the Board, was in attendance. Roll call disclosed the presence of the following named Directors, viz:

W. R. Bennett

E. E. Bewley

C. A. Hickman

W. S. Cooke

W. K. Stripling

At this meeting the following proceedings were had and done, viz:

- 1. The minutes of the meeting of May 1, were read, approved and ordered of record.
- 2. Thereupon there was submitted to each of the Directors a statement of the Financial Condition of the District as of this date. The statement included obligations and accounts payable by the District. The current obligations payable, including the former voucher issued to G. W. Duke (#1236), totaled the sum \$2350.56. Said itemized list of obligations is hereto attached as EXIBIT "A", and is made part hereof.
- 3. Thereupon Director E. E. Bewley did move, and Director Cooke did second the motion, that the stated accounts do be approved and that vouchers do be issued to cover each and all of the stated obligations, other than the item #1236, heretofore paid to G. W. Duke. Upon a vote being taken the motion was carried and it is so ordered.
- 4. Thereupon there was presented a request for the Engineers for the advancement of \$10,000.00, as payment to them on their contract for engineering service. Upon analysis of the condition of the account, the service rendered and the amount available with the Depository for the payment of said request, Director W. K. Stripling did move, and Director W. S. Cooke did second the motion, that the request be approved, and that voucher for \$10,000.00 do be issued, payable to the order of Hawley & Freese, District Engineers, provided however, the actual voucher should not be delivered until funds for the protection thereof had been provided. Upon a vote being taken the motion was carried and it is so ordered.
- 5. President Bennett desired to know from Director E. E. Bewley, as Chairman of the Finance Committee, if he had arranged for the sale of the \$10,000.00 of preliminary District Notes, as contemplated by the minutes of the meeting of May 1, 1928. Director Bewley stated that he had not done so, but

that he would do so immediately; that he did also desire a motion which would authorize the issuance of a voucher to cover the advance payment of interest on the obligations. Thereupon Director Cooke did move, and Director C. A. Hickman did second the motion, that the President and Secretary do actually execute ten (10) of the preliminary Bonds for the District, now held in the Treasury to be serial numbers 106 to 115, for the par sum One Thousand (\$1,000.00) Dollars each, both inclusive; further that Director Bewley do be authorized to sell the same for maturity on July 1, 1928; further that the District's voucher #1264, for the sum of \$73.61, payable to the order of The Continental National Bank, do be issued and delivered to Director Bewley, for delivery to the Bank upon consummation of the sale of the Bonds. Upon a vote being taken the motion was carried and it is so ordered.

- 6. Director C. A. Hickman did move, and Director Stripling did second the motion, that the regular meeting for Tuesday, May 8, do be vacated due to the fact that all accumulated business of the District had been disposed of in the meeting held this day. Upon a vote being taken the motion was carried and it is so ordered.
- 7. There being no further business the meeting was declared adjourned.
