- 2. Secretary Stripling then presented the bonds and oaths of office of W. S. Cooke and C. A. Hickman, re-elected directors; said bonds and oaths of office were examined by the directors and counsel for the district, and upon advice of counsel, were found to be good and sufficient bonds and caths of office and in conformity to law. The reupon, Director Bewley moved that the directors do approve the bonds and oaths of office of the said W. S. Cooke and C. A. Hickman. Further, that President Bennett and Secretary Stripling do execute the approval of each of said bonds as the act and deed of the district and that the original bonds and oaths of office be filed, as required by law, and that a copy of the original of each be attached to and become a part of these minutes. The motion was seconded by Director Stripling. Upon a vote being taken the motion carried unanimously, and it is so ordered.

3. President Bennett called for the written report of the District Engineers, on the petitions of C. A. Boaz, et al., William Fay Kingsbury, et al., G. P. Reeves, L. P. Reeves, and M. G. Reeves, which petitions had been presented to the Board at their meeting held on January 31, 1929, and ordered referred to the District Engineers for report. Thereupon, Major Hawley of Hawley & Freese, District Engineers, presented their written report which was read. Director Stripling moved that the report, as read. be received and that the petitioners be notified by letter, that said re-April 2, 1929) port is on file in the District's office, that they were at liberty to read the report and also to notify them that the Directors will, at the meeting to be held at 10:00 o'clock a. m. on Tuesday April 2, 1929, in the District's office, consider said Engineers' report: that at said meeting the petitioners may present such additional facts for the consideration of the Board as they may deem proper and that a full hearing will be accorded to each of the petitioners upon matters embraced in their petition. After reading same Director Stripling moved that said notice be published in the Fort Worth Record-Telegram, in their issues of March 9, 16 and 23, 1929, and that a copy of said Notice be attached to and made a part of these minutes. This motion was seconded by Director Hickman. Upon a vote being taken the motion carried unanimously and it is so ordered.

Auditor for District Books for year of 1928.

6. Director Cooke made a motion that Director Bewley, Chairman of Legal and Financial Committee, designate and enter into contract with an auditor to make an audit of the District's books for the period January 1, 1928 to and including December 31, 1928. The motion was seconded by Director Hickman. Upon a vote being taken the motion carried unanimously and it is so ordered.

Advisability of auditing John Pengilly Books, Tax Collector for creation, to be reported on at meeting of April 2, 1929.

7. Director Cooke made a motion that the matter of advisability of auditing the accounts of John Pengilly, who has been the Tax Collector for this District from its creation to and including December 31, 1928, be referred to the Committee on Office Organization. This Committee is comprised of W. S. Cooke, Chairman: W. R. District since Bennett and E. E. Bewley, alternate, who are to report on this matter at the meeting to be held on April 2, 1929. Directors Stripling seconded the motion. Upon a vote being taken the motion carried unanimously and it is so ordered.
