MINUTES OF A CALLED MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD ON MARCH 3, 1931, AT THE DISTRICT OFFICE IN FORT WORTH, TEXAS AT 10 O'CLOCK A. M., IN CONFORMITY TO THE PUBLISHED NOTICE CONCERNING BIDS AND THE SELECTION OF A DEPOSITORY FOR THE DISTRICT

The call of the roll disclosed the presence, or absence, of Directors as follows, viz:

THERE WERE ALSO PRESENT: John H. Eriksen, Cashier of the Continental National Bank of Fort Worth, Texas, who appeared as a representative of said Bank; &

> W. H. Wallerich, Asst. Vice-President of the First National Bank of Fort Worth, Texas, representing said First National Bank.

At this meeting the following proceedings were had and done viz:

Director W. R. Bennett presided in his capacity as President; Director W. K. Stripling acted in his capacity as Secretary.

President Bennett produced a published Notice of the intention of this District to receive Bids for a Depository for the funds of this District, and to make a selection of a Depository, based thereon. A copy of said Notice together with the Publisher's affidavit showing the publication of same in accordance with the law, is attached to these Minutes, marked "Exhibit A," and made part hereof as though embraced within the body of these Minutes: He thereupon called for the delivery of sealed bids. Thereupon sealed bids were delivered for opening: These bids were as follows:

(a) Continental National Bank of Fort Worth, bid upon the Construction Fund, and to be paid on the actual balances, interest at the rate of One and One-Half (1-1/2%) per cent.; AND on the Interest and Sinking Fund Account, interest at the rate of Two and One-Quarter (2-1/4%) per cent. Said written bid is attached to these Minutes as "Exhibit B," and is here referred to as part hereof.

(b) First National Bank of Fort Worth, Texas, bid upon the Daily balances appearing to the credit of the District on all accounts, interest at the rate of One and One-Quarter (1-1/4%) per cent. Said written bid is attached to these Minutes as "Exhibit C," and is here referred to as part hereof.

No other person whatever appeared to tender a bid. Said sealed bids were opened and publicly read in the hearing of all persons interested therein.

There was extended consideration of the bids, WHEREUPON it became the opinion of the Directors that no final action should be had thereon until the return of Director E. ^E. Bewley, who was absent from the City: The meeting was therefore recessed, subject to call at such time as it might be possible to have Director Bewley present in his capacity as Chairman of the Committee on Finance.

On this the 9th day of March, 1931, the Called Meeting, recessed as hereinabove related, was convened upon call at 2:30 p. m., at which time there were present:

At this time and place there was full consideration of the two bids tendered on March 3, 1931, WHEREUPON Director Bewley made a motion:

(a) That the bid of the First National Bank do be rejected, and that the good faith check for the sum \$3750.00, deposited with by them with their bid, do be returned to them.

(b) That the bid of the Continental National Bank of Fort Worth do be approved in accordance with its terms: That said Continental National Bank of Fort Worth, Texas, do be declared to be the highest and best bidder to become a depository for this District, and that it be selected as such Depository for the period to begin March 3, 1931, and to serve until February 28, 1933, or so much longer as may be required to qualify a successor Depository; which time, however, shall not be later than sixty (60) days next after February 28, 1933. It is provided, however, that this selection and designation of a Depository for this District shall be subject to the condition that said Continental National Bank of Fort Worth do actually qualify as such Depository in the man er required by law and to conform to the requirements of the Board of Directors of this District, concerning the sufficiency of the security to be given. This motion was second-

Stripling did not participate due to the fact that each of them is a stock holder in said Continental National Bank. The motion was carried and it was so ordered.
