At this time and place the following proceedings were had and done, viz:

The District's Voucher Check No. 3056, payable to J. Lester Wright, Tax Assessor for Tarrant County, Texas, to compensate him for service rendered to this District for the assessment of the District's taxes for the year 1932, was presented for consideration. It appeared that all service required under the district's contract with the payee had been done and performed, whereupon Director Bewley made a motion that said Voucher Check No. 3056, payable as aforesaid, and for the purpose aforesaid, do be executed and delivered to said payee in payment of said account. Adoption of this motion was seconded by Director Hogsett. The motion was carried and it was so ordered.

2.

There was presented to the Directors for consideration two bids for certain bonds of the District, which written proposals, in folio, are attached to the minutes of this meeting as "Exhibit A," and as part hereof. Said written bids are designated as follows:

The bid of Frazier Moss & Company; and, the bid of Geo. L. Simpson & Company.

There was full consideration of these two bids, whereupon Director Bewley made a motion that each and both of said bids do be rejected and the respective bidders notified. Adoption of this motion was seconded by Director Hickman. Upon a vote being taken the motion was carried and it was so ordered.

There was presented to the Directors for consideration the facts relating to the difficulty being encountered in procuring the service of John Bourland, as Tax Collector for the District for the year 1933. There was also presented the apparent need of the District to have the law clarified in such manner as would prevent recurrence of a similar situation, both with reference to the Tax Collector and the Tax Assessor. Thereupon Director Hickman made a motion that the Attorneys for the District prepare clarifying legislation, and that they do seek the aid of the Senators and Representatives of Tarrant County, Texas, in procuring the passage of such an act. This motion was seconded by Director Hogsett. Upon a vote being taken the motion was carried and it was so ordered.

No further business was presented and the meeting was adjourned.
