The call of the roll disclosed the presence of all Directors as follows, viz:

W. R. Bennett
E. E. Bewley
W. K. Stripling
C. A. Hickman
Joe B. Hogsett.

Director Bennett presided in his capacity as President of the Board; Director Stripling acted in his capacity as Secretary of the Board. At this time and place proceedings were had and done as follows, viz:

1.

President Bennett stated that the meeting had been called for two purposes, viz: (1) To provide for the election of officers of the Board of Directors of the District, for the year 1933, and to choose members for services on the various standing Committees established by the Directors of the District; and (2) To consider the bonds of Directors Hickman and Hogsett, which by their terms would expire on the 13th day of January 1933.

Director Hickman made a motion that the Board of Directors do establish as its statutory officers for the year 1933, the following:

- W. R. Bennett shall be President of the Board of Directors of this District;
- E. E. Bewley shall be Vice-President of the Board of Directors of this District; and
  - W. K. Stripling shall be Secretary of the Board of Directors of this District.

All members serving on the respective Committees established by this District during the year 1932, shall continue to serve on their respective Committees for the year 1933. Directors E. E. Bewley and Joe B. Hogsett shall continue to be Custodians of all authorized bonds of the District, executed, registered, but not sold, and of all securities which may be placed in pledge for the securing of deposits of the District, by the District's Depositary for the year 1933. However, it is provided that their service shall not cast upon

them any responsibility other than that of continuing to use the same care for the preservation of said security as has been used in prior time.

Adoption of this motion was seconded by Director Hogsett,
Upon a vote being taken the motion was carried by lawful majority vote —
There was no contrary vote, and it is so ordered.
