MINUTES OF A CALLED MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD IN THE DISTRICT OFFICE IN FORT WORTH, TEXAS, ON THE 9TH DAY OF MAY, 1933, 3:30 P. M.

The call of the roll disclosed the presence of all Directors as follows, viz:

W. R. Bennett E. E. Bewley W. K. Stripling C. A. Hickman Joe B. Hogsett

President Bennett presided; Director Stripling acted in his capacity as Secre-

tary.

At this time and place the following proceedings were had and done, viz:

1.

President Bennett presented to the District a check delivered to him by Mr. Frank Turner, as President of the First National Bank of Bridgeport, Texas. This check was issued by the Treasurer of the United States, being serial number 19837, dated May 5, 1933, for the sum \$50.00, payeble to "B. L. Brown and Tarrant County Water Control District No. 1."

It was explained that Mr. Brown was the lessee of some land under contract made between the District and Mr. W. D. Young; further, that the District was in possession of Mr. Young's check, to cover the agreed rental at \$50.00, to cover tenancy from January 1st, to December 31st, 1933, and relating to the land purchased by the District from the Lyles Heirs. It further was explained that this land was the same as that covered by a lease to Hutto Brothers, approved at a meeting of the Directors held on October 14, 1932, as shown in Minute Book 26, page 3, Item 1, which lease agreement had been forfeited by Hutto Bros. It was also explained that the payment by Mr. Young was for the use and benefit of Mr. B. L. Brown, and that upon the payment of Mr. Young's check, the District could have no interest in the Treasurer's Check above described.

Upon consideration of this matter, Director Hogsett made a motion that the prior authorization for lease of the Lyles' land to Hutto Brothers be revoked and for naught held; that lease of this land in the usual form to cover the period from January 1 to December 31, 1933, to B. L. Brown, as lessee, do be authorized and executed for the District by W. R. Bennett as President; subject only to delivery of the lease upon actual payment of said sum \$50.00, as represented by the check of Mr. Young. Further, that President Bennett do endorse the above described Treasurer's Check and transmit the same to Mr. Frænk Turner in his capacity as President of the First National Bank of Bridgeport. This motion was seconded by Director Hickman. Upon a vote being taken the motion was carried and it was so ordered.

2.

Thereupon there was presented to the Directors for disposition 45 Notes, executed in the name of the District, payable to Reconstruction Finance Corporation, for the principal sum \$10,000.00 each, numbered serially from 1 to 45, both inclusive, which notes had been executed in the name of the District as of date February 13, 1933, and which under prior orders of this District had been registered as obligations of this District in the office of the Comptroller of the State of Texas. The notes here designated, due to the making of other and different terms with Reconstruction Finance Corporation no longer have usefulness or value, and the registration of same with the Comptroller will falsely reflect the financial condition of this District.

Upon consideration of this matter, Director Hogsett made a motion that all prior orders relating to the execution and registration of said notes do be revoked and for naught held; further, that the appropriate officers and attorneys for this District do procure cancellation of the registration of said notes in the office of the Comptroller of the Stateof Texas, and that said notes do now, in the presence of all the Directors, be mutilated as to signatures thereon so that the same might no longer offer evidence of indebtedness on the part of this District. Adoption of this motion was seconded by Director Hickman. Upon a vote being taken the motion was carried, whereupon the actual presence of said notes was verified by the Directors of the District and said notes were mutilated in the presence of all of said Directors.

3.

Attached to these Minutes as "Exhibit A," is a report by the Finance Committee, signed by Director Bewley and Director Hogsett, dated April 5, 1933, and relating to the fact that coupon No. 3, attached to each of 811 bonds of the District of "Series D," maturing March 15, 1933, and being bonds of series "D" of the District which were unsold on March 15, 1933, had been clipped and mutilated as to the signatures so that said coupons could not offer evidence of indebtedness by this District. Attached to said report are exhibits showing the detail of said transaction, and reference here is made to said exhibit as part hereof. Said 811 coupons, in the presence of the Board, were identified as to number and each of said coupons were shown to have been mutilated so that the same no longer might pass as evidence of indebtedness. Whereupon Director Stripling made a motion that said action by the Finance Committee be approved. That they be discharged as to further

liability concerning said coupons and that the General Auditor for the District be requested to verify the facts relating to the clipping and mutilation of said coupons. This motion was seconded by Director Hickman. Upon a vote being taken the motion was carried and it was so ordered.

4.

Attached to these Minutes as "Exhibit B," is a statement showing the Financial Condition of this District as of this day, showing voucherchecks issued for the total sum 4470.04, and also showing proposed voucher checks Nos. 3165 to 3186, both inclusive, proposed to be issued to effect payment of accounts now due and payable by the District in the total sum \$1741.18. Reference here is made to said "Exhibit" as part hereof. There was full consideration of the proposed voucher checks and the data to support the same, whereupon Director Hogsett made a motion that the accounts represented by said voucher checks do be approved for payment and that said voucher checks consecutive serial numbers 3165 to 3186, both inclusive, do be executed and delivered to the several persons entitled to receive the same. This motion was seconded by Director Hickman. Upon a vote being taken the motion was carried and it was so ordered.

5.

Thereupon there was presented an itemized statement of the expense of Ireland Hampton to cover expenditures during his trip to Washington, in an effort to close the loan desired by the District from Reconstruction Finance Corporation. Due to the lateness of the hour, said account was not examined but it was the sense of the Directors that the District Voucher Check No. 3187, for the sum \$800.00, payable to Ireland Hampton do be issued and delivered

to him as payment on account. It was so ordered.

6.

No further business was presented and the meeting was adjourned.
