MINUTES OF A CALLED MEETING OF THE BOARD OF DIRECTORS OF TARRANT COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE HELD IN THE DISTRICT OFFICE IN FORT WORTH, TEXAS, ON THE 7TH DAY OF AUGUST, 1933, 3 P. M.

The call of the roll disclosed the presence of all Directors as follows, viz:

W. R. Bennett

E. E. Bewley

W. K. Stripling

C. A. Hickman

Joe B. Hogsett

At this meeting W. R. Bennett presided as President; Director Stripling acted in his capacity as Secretary.

At this time and place the following proceedings were had and done, viz:

1.

Director Bewley reported that on August 5, 1933, Reconstruction Finance Corporation caused to be deposited in the Continental National Bank of Fort Worth, Texas, as the designated depository of this District, the sum of \$459,008.00, which sum represents the contract consideration for the 463 bonds of this District for the par sum \$463,000.00, designated as "Series D-2".

He stated that at this time said deposit was a separate deposit to the credit of the District and had been designated as "R. F. C. Special Fund." He further reported that \$450,012.85 of the total deposit represented the purchase price of said bonds, without adding thereto the interest accrued on the coupons numbered "4", attached to said bonds. As to said accrued interest it appeared that there had been paid an additional sum \$8995.15, which represented the interest on Coupon No. 4, attached to each of said bonds, maturing on September 15, 1933; that said sum \$8995.15 represented interest accrued on said bonds from March 15, 1933 to August 5, 1933, being for 143 days @ the rate of 5% per

annum as provided for in said coupons. Mr. Bewley reported that at the time of the making of said deposit and in order to secure the same, he had received into pledge direct obligations of the United States of America, for a total par value, exclusive of accrued interest, \$460,000.00.

Attached to these Minutes as "Exhibit A," is a document, dated July 25, 1933, marked "Exhibit No. 2" to be attached to the bond of Continental National Bank," showing pledge of Treasury Notes of the United States for the par sum \$60,000.00, which document is a reciprocal receipt executed by the Continental National Bank of Fort Worth and by Director E. E. Bewley, as Custodian of pledges for this District; reference here is made to said Exhibit as part hereof.

Attached to these Minutes as "Exhibit B," is a document, dated August 4, 1933, marked "Exhibit No. 3", showing the withdrawal from pledge of obligations of the United States of America, for the total par sum \$125,000.00; and the substitution in pledge, bonds of Fort Worth Independent School District, for the par sum \$138,000.00. Said document was executed by said Continental National Bank, and by said E. E. Bewley, in his capacity as Custodian of Pledges for this District, and reference here is made thereto as part hereof.

Attached to these Minutes as "Exhibit C," is a document, dated August 5, 1933, marked "Exhibit No. 4," showing the deposit in pledge by said Continental National Bank, of the direct obligations of the United States of America, therein described, having total par value, exclusive of the interest accrued, of the sum \$460,000.00. Said exhibit recites that the securities therein described and thereunder pledged were in pledge exclusively to secure

the Special Fund of \$459,008.00, made on said August 5, 1933, as consideration for the purchase of the bonds of this District (being 463 bonds designated as "Series D-2" of this District). Said document was executed by said Bank and made provision for execution in behalf of the District by the President of the District and to be attested by the Secretary of the District.

Upon consideration of all of said matters, and upon recommendation by Director Bewley, Director Hickman made a motion as follows:

(a) That the pledge of securities made on July 25, 1933 ("Exhibit No. 2") be ratified and approved as the act and deed of the District; (b) That the withdrawal of securities and the substituti n of securities made on August 4, 1933 ("Exhibit No. 3), be ratified and approved as the act and deed of the District; (c) That the pledge of securities heretofore effected under "Exhibit No. 4" on August 5, 1933, do be ratified and approved as the act and deed of the District; further, that said Reciprocal Receipt (being "Exhibit No. L"), do be executed in the name of the District by its President and that the same do be attested by the Secretary of the District, with the District's seal. Further, that the pledges described in said "Exhibit No. 4" do be treated as a pledge separate and apart from other pledges made to the District, for the purpose of securing said deposit of \$459,008.00 derived from the proceeds of the bonds sold to Reconstruction Finance Corporation, and as well to secure all subsidiary Special Accounts as might grow out of the Special Account designated as "R. F. C. Special Fund." (d) Further, that one each of the Reciprocal Receipts, designated as "Exhibits Nos. 2, 3 and 4" do be attached to the bond of Continental National Bank of Fort Worth as exhibits, as is provided for in said bond and contract for the pledge of collateral security.

Adoption of this motion was seconded by Director Stripling.

Upon a vote being taken the motion was carried and it was so ordered.

Director Bewley made a motion that the sum \$8995.15, now embraced in the Deposit designated as "R. F. C. Special Fund," representing the interest accrued on the bonds of Series D-2 of this District, between March 15 and August 5, 1933, do be transferred to the Interest and Sinking Fund of this District; further, that in order to effect such transfer the District's Voucher Check No. 3299, for the sum \$8995.15, do be drawn against said "R. F. C. Special Fund," payable to the Interest and Sinking fund of this District.

Director Hickman moved the adoption of the said motion. Upon a vote being taken the motion was carried and it was so ordered.
