President Hickman stated that the object for the call of the Meeting was as follows:

That the District has sold and delivered bonds of the District, being bonds of "Series D", as issued by the District, at various times from September 13, 1933 to December 4, 1935, of the total par value \$90,000.00. That these bonds have been sold under separate orders of the Board; that they have been delivered to the respective purchasers upon Preliminary Approving Opinion given by Messrs. Chapman & Cutler, Bond Attorneys of Chicago, Illinois; that of the 90 bonds so sold and delivered, all save five bonds sold to Jack County, Texas, in lieu of money, to satisfy a valid claim of that County against this District, were sold for money to replenish the "Construction Fund" of the District; that all of the present holders of said 90 bonds desire final approving opinion by Messrs. Chapman & Cutler; that it is desired to avoid multiple approving opinions based on each order of sale by including all of said transactions in one blanket order confirming these prior sales of bonds.

Attached to these Minutes as "Exhibit A," to have the same effect as though fully set out at this place, is a full and true tabulation showing:

The serial numbers of said 90 bonds of "Series D"; the respective dates on which they were authorized to be sold and delivered; the names of the purchasers of the specified bonds; the dates on which the proceeds

of the bonds were covered into the Depositary Bank of the District (save in the case in which the claim of Jack County, Texas, was satisfied by the delivery of bonds); and the designation of the account in which all such deposits were placed.

Also attached to these minutes, as "Exhibit B," is a copy of excerpt from the minutes of the District, relating to the sale of bonds to satisfy the claim of Jack County, Texas, affecting five bonds having serial numbers 5872, 5929, 5988, 6050 and 6115, having aggregate par value of \$5,000.00.

Further that, the appropriate officers and agents of this District do any and all things required to be done to satisfy Messrs. Chapman & Cutler, Bond Attorneys of 111 West Monroe Street, Chicago, Illinois, concerning all facts required by them as a basis for issuing their final approving opinion concerning the validity of said bonds and the sale thereof: Be it so ordered."

McClure as County Judge of Jack County, Texas, dated November 18, 1933, wherein it was stated that Jack County cannot accede to the recent proposal made by this District, in settlement of the road claims of Jack County against the District; but, that the County would receive in settlement of the claim either five bonds and \$500.00 in cash, or six bonds. Upon consideration of this matter Director Stripling made a motion that the District do tender to Jack County, in settlement of said claims, five bonds of the district, of the first maturities available plus the interest accrued on the coupons maturing September 15, 1934, and a balance to make up \$500.00 (the cash and accrued interest to equal \$500.00), the cash involved to be paid to Jack County at such time as the required sum might be available in the District's Construction Fund. This motion was seconded by Director Hickman. Upon a vote being taken the motion was carried and it was so ordered.

That the total par value of the bonds heretofore sold is \$6,450,000.00, and of the bonds so sold bonds having par value \$170,000 have been paid off and discharged as the same matured. All bonds now remaining unsold are bonds of Series "D", bearing date November 16, 1931, having maturities as follows, i. e.:

13 bonds in the year 1970; 37 bonds in the year 1971.

We further certify that: (a) No land has been excluded from this District since January 1, 1931.

- (b) The Directors and officials of this District have supplied proper surety bonds for the current fiscal year and said bonds have been approved in the manner required by law, and all of the Directors of this District have been duly qualified in a manner conforming to the appropriate law.
- (c) This District has not entered into a contract of any nature with the United States Government, save one for an out-right grant to be approximately thirty per centum of the cost of certain levee improvements in the city of Fort Worth, now under contract for completion for the sum \$98,466.37.
- (d) No change has been made in the basis of taxes for said District since January 1, 1931, and all taxes of the District are levied on an ad valorem basis.
- (e) The Board of Directors of this District has not adopted a debt limit.
