The call of the roll disclosed the presence or absence of Directors as follows:

Director Newton acted in his capacity as President and Director Hudson acted in his capacity as Secretary, whereupon proceedings were had and done as follows:

On motion duly made and seconded, the minutes of the meeting held September 12, 1972 were read and approved by the Directors and it was accordingly ordered that such minutes be placed in the permanent files of the District.

On motion of Director Penry, seconded by Director Shannon, voucher-checks #11924 thru #12060 inclusive, Maintenance Fund; voucher-checks #3081 thru #3112 inclusive, Construction Fund; voucher-checks #402 thru #404 inclusive, Interest and Sinking Fund; voucher-checks #3057 thru #3081 inclusive, Revenue Fund and voucher-checks #3750 thru

#3771 inclusive, Cedar Creek Construction Fund were approved and ordered paid. All Directors voted aye thereon.

President Newton stated that the District had advertised for bid proposals relating to the leasing of certain lands owned by the District in Wise County, Texas, for Oil, Gas and other Minerals and presented the one (1) bid proposal received, to wit:

Mr. Ben Hickey recommended the acquisition in fee of four (4) tracts of land and improvements all in the Lakevue Estates in Wise County, to wit:

(a) Lot 4, Block 11 - R. L. Rodgers et ux @ \$9,000.00; (b) Lots 9 and 10, Block 4 - Lee E. Murray et ux @ \$13,750.00; (c) Lots 2 and 3, Mildred Pruitt @ \$13,500.00 and (d) Lot 13, Block 4 - Howard H. Pruitt @ \$10,200.00.

Following a discussion, Director Penry made a motion, seconded by Director Hudson and unanimously passed, that the above mentioned four (4) tracts be acquired as presented.

There was presented to the Directors four (4) bid proposals to purchase from the District 57.07 acres more or less, Tract #1 and three (3) bid proposals to purchase from the District 99.21 acres more or less, Tract #2, now surplus to the needs of the District, located in Henderson County, Texas to wit:

All bid proposals were submitted on bid forms prepared by General Counsel of the District, outlining certain terms and covenants acceptable to District.

Following a general discussion, Director Penry made the motion, seconded by Director Hudson, and unanimously approved, that the bids of Tom Steigleder in the amount of \$95,246.89 for Tract #1 and \$161,874.72 for Tract #2 be accepted as presented, and that authorization be now given for officers of the District to execute the necessary legal instruments conveying title to the said Tract #1 57.07 acres, more or less and Tract #2 99.21 acres more or less, upon preparation by General Counsel for the District.

6.

President Newton presented a request from the Texas Highway Department for an easement covering 30.172 acres more or less located in the Garcia, Montez and Durant Surveys all in Tarrant County, Texas, and more particularly described by a metes and bounds description filed in the permanent records of the District. In reviewing the request it was explained that the easement was to be used as right-of-way in the construction of Interstate Highway 820, and that the consideration of \$62,850.00 was based on well established appraisal methods.

Following a more detailed discussion Director Mason made a motion, seconded by Director Penry, and unanimously passed, that with the recommendations of management and engineers for the District, an easement be granted as prepared by General Counsel of the District for the consideration of \$62,850.00 to be paid by the Texas Highway

Department.
