MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF TARRANT REGIONAL WATER DISTRICT HELD ON THE 19th DAY OF March 2019 AT 9:00 A.M.

President Stevens convened the meeting with assurance from management that all requirements of the "open meetings" laws had been met.

1.

All present were given the opportunity to join in reciting the Pledges of Allegiance to the U.S. and Texas flags.

2.

On a motion made by Director Leonard and seconded by Director King, the Directors voted unanimously to approve the minutes from the Board meeting held on February 19, 2019. It was accordingly ordered that these minutes be placed in the permanent files of the District.

3.

With the recommendation of management, Director Leonard moved to approve a contract with CDM Smith in the amount of \$340,524 to perform refinement of the Fort Worth Floodway CE-Qual W2 Model. This contract will develop water quality management strategies for the Fort Worth Floodway during low flow and seasonal flow conditions. Funding for the item is included in the Fiscal Year 2019 and Fiscal Year 2020 General Fund Budget. Director King seconded the motion and the vote in favor was unanimous

4.

With the recommendation of management, Director Hill moved to approve a contract with Arcadis in the not-to-exceed amount of \$496,060 for Phase 4 of the Asset Management project to expand the existing asset management program to the District's reservoirs. Phase 4 will also build upon the asset risk assessment work done in Phases

1 through 3 to prepare a risk and resilience assessment for the District's water supply system as required by the Water Infrastructure Act of 2018. Funding for the item is included in the Fiscal Year 2019 Revenue Fund Budget. Director King seconded the motion and the vote in favor was unanimous

5.

With the recommendation of management, Director Leonard moved to approve a purchase from Thompson Group in the amount of \$533,377 for 72" E-301 pipe to replace 14 damaged pipe segments of the Cedar Creek Pipeline during Fiscal Year 2020. The lead time for pipe delivery necessitates budgeting and purchasing in Fiscal year 2019. The damaged segments are in Section III located between the Ennis Booster station and the Waxahachie stations. Funding for the item is included in the Fiscal Year 2019 Revenue Fund Budget. Director Hill seconded the motion and the vote in favor was unanimous.

6.

With the recommendation of management, Director King moved to approve a credit change order with BAR Constructors, Inc in the amount of \$985,431.83 for reconciliation of extra work and allowance items and deletion of final access road work in the Joint Cedar Creek Lake Pump Station Package 1 Intake Project. BAR is scheduled to achieve final completion and contract close out in April 2019. The current contract price is \$19,945,645.92 and the revised total not to exceed contract price, including this change order, will be \$18,960,214.09. The District is currently holding retainage in the amount of \$499,123.83 that will be released at final completion. Funding for this credit change order is included in the Bond Fund. Director Leonard seconded the motion and the vote in favor

With the recommendation of management, Director Hill moved to approve a change order with BAR Constructors, Inc. in the amount of \$297,605.91 for the Joint Cedar Creek Lake Pump Station Project contract for pump station site access road work and Henderson County road repairs. This is the road work that was deleted from the Joint Cedar Creek Pump Station Package 1 Intake Project. The current contract price is \$63,011,238.48 and the revised total not-to-exceed contract price, including this change order, will be \$63,308,844.39. Funding for this item is included in the Bond Fund. Director Leonard seconded the motion and the vote in favor was unanimous.

William M. Key, Sr., et al.*, Cause No. 00103-CCL-16 in the County Court at Law No. 1, Henderson County, Texas; Tarrant Regional Water District v. William M. Key, Sr., et al., Cause No. 00168-CCL-16 in the County Court at Law No. 1, Henderson County, Texas); and under Section 551.072 to Deliberate the Purchase, Exchange, Lease or Value of Real Property. Upon completion of the executive session at 10:45 a.m., the President reopened the meeting.

With the recommendation of management, Director King moved to grant authority to acquire permanent easement interests, as set forth below, in, over, under, and across the following described properties for the public use and purpose of construction and operation of the Integrated Pipeline Project. Funding for this acquisition is included in the Bond Fund.

IPL Parcel 818 Frankston ISD

Permanent easement interests across a 10.866-acre tract of land and a 0.535 - acre tract of land, each situated in the Joseph Ferguson Survey, Abstract Number 23, Anderson County, Texas, and being more particularly described as a portion of that certain 68.54-acre tract (Tract No. 2) conveyed to Frankston Independent School District by deed, as recorded in Volume 674, Page 459, Deed Records of Anderson County, Texas, and being further described in the accompanying survey plats for Parcel 818 and Parcel 818.TE attached hereto for the negotiated purchase price of \$400,000.

Director Leonard seconded the motion and the vote in favor was unanimous.

Funding for this settlement is included in the Bond Fund. Director King seconded the motion and the vote in favor was unanimous.

With the recommendation of management, Director Leonard moved to grant authority to acquire permanent easement and right-of-way interests in, over, under, and across a strip of land being approximately 20 feet wide by 100 feet long located at or near Fort Worth & Western Railroad Company ("FWWR") Milepost 3.2 in the George Shields Survey, Abstract No. 1402, such land to be conveyed to TRWD being more specifically depicted in the accompanying map hereto (the "Property"). Funding for this acquisition is included in the Fiscal Year 2019 General Fund.



In addition, the General Manager or his designee is granted authority to execute all documents necessary to complete these transactions and to pay all reasonable and necessary closing and related costs incurred with these acquisitions. Director Hill seconded the motion and the vote in favor was unanimous.
